# PROCEEDINGS 68th ANNUAL STATE CONVENTION MISSISSIPPI STATE COUNCIL KNIGHTS OF COLUMBUS

First Session: Friday, May 5, 1972

The 68th Annual State Convention of the Mississippi State Council of the Knights of Columbus was opened at 6:00 P.M. by the Grand Knight of the Greenville Council. The Hon. Pat Dunne, Mayor of Greenville, welcomed the delegates to Greenville. State Secretary Henry J. Foggo responding for the State Council, thanked Mayor Dunn for his cordial welcome.

The Grand Knight of Greenville turned the gavel over to State Deputy William F. La Forge who officially called the Convention to order. The opening prayer was led by the State Chaplain, Bishop Brunini. The pledge of allegiance to the flag was recited by all present.

State Warden Mike Columbus verified all traveling cards and reported that they were current and correct.

The State Deputy read the following Communication from Supreme Knight John W. McDevitt:

Worthy State Deputy and Dear William:

We are privileged to send fraternal greetings to you, the officers and delegates of your 1972 State Council meeting.

You embark on your annual deliberations at a time of world crisis. This crisis stems in large part from the staggering contrast between the swiftly rising physical progress of man and the lag in his religious and cultural development.

We have experienced more across-the-board scientific development in the last two generations than has been witnessed in the years since life first began on this planet. We have seen the creation of more creature comfort in the past generation than men prior to us had engineered since the stone age.

In contrast to this sensational rise in scientific development we find that men still show themselves indifferent to and disrespectful of the life, limb and goods of others. This lack of moral development has led to war between nations and crime in our streets.

The frailties of human nature always will be with us but man must raise his hopes, ambitions and ideals to a high moral plane if ever the promise of science is to bring him true fulfillment. Science is a tool, but not the answer. The answer lies in an acknowledgement of the Fatherhood of God and the brotherhood of men.

Fraternal organizations with a strong religious orientation such as ours are eminently qualified to impress on the world God's Fatherhood and to impart to all men a true sense of fraternity. To this end we commend your deliberations.

REYNOLDS RIDGLEY, CHAIRMAN HENRY J. FOGGO FRANCIS MARTIN

The State Deputy asked if there were any communications. There were none so he called for the State Chaplain's report.

Worthy State Deputy and fellow Officers, I am privileged to present my Annual Chaplain's Report at this time. First of all, I know I echo the sentiments of all of us when I say that we are happy to gather in this Queen City of the Delta, a city which enjoys a unique place in the history of the Church in Mississippi and has been the anchor of many fine activities throughout this important region of our State.

Greenville, Washington County, and the Delta in general are all moving forward rapidly and I am sure will play an even greater role in future progress. The pastor of St. Joseph Church here in Greenville is traditionally the Dean of the North Central Deanery. I know that Monsignor Harkins, the pastor and Dean-Episcopal Vicar, will give us a warm welcome.

I would like to report that our Emeritus State Chaplain, Bishop Gerow, is very comfortably situated at St. Dominic's Hospital in Jackson. A few days ago he celebrated his 87th birthday and next month will be a priest for 63 years and a bishop for 48 years. The Bishop is able to receive occasional short visits in Room 650 at St. Dominic's. Just before I left Jackson he asked me to extend his heartiest greetings to the Convention.

I am happy that the local Grand Knights have accepted my suggestion that they invite their local chaplains to the State Convention, and I trust that several of them will be able to come in spite of heavy week-end duties.

Let me take this opportunity to officially thank our State leadership and all of our local Councils for their continued generosity in providing for the cost of education of our future priests. Next month I will go to Ireland for the ordinations of three young men for our diocese. In the foreseeable future we will not have as many Irish priests joining our diocesan priests. Probably we can expect about one priest a year from this saintly land that has provided so many priests for us.

Both His Eminence, Cardinal Conway, and Father P. J. Brophy, president of St. Patrick's College, Carlow, on recent visits to Mississippi have given us notice plainly that we must develop more vocations here in Mississippi. We do hope that the Knights will take leadership in this matter.

Each parish is expected to have a Vocations Committee and is looking for volunteers for this committee.

Father Henry Shelton, our Diocesan Director for Vocations, addressed the Convention last year in Natchez, and is securing increased cooperation and success in his promotion of vocations in Mississippi and from other parts of the United States. As Cardinal Conway stated on his visit to Mississippi, "the world will always have plenty of social workers, plenty of psychologists and plenty of teachers of secular subjects, but more priests is what the world needs in these important days." Many of our younger priests are suffering from frustration not at all uncommon in modern society and I know that the Knights have been and will continue to be sources of support to these priests.

We are pleased to note that most of the Councils do have Disaster Committees with plans to spring into action immediately when local disasters strike. We do need to make further progress for our committees on Social Justice and Social Peace. I would like to make a practical suggestion that is, that at our next Convention the State Chairman in cooperation with the local Chairman have a panel entitled "The Knights of Columbus and Social Justice." Perhaps six panelists could be secured including two members of the Knights of Columbus Women's Auxiliary. I would also suggest that the panel discussion be open to all attending the Convention.

As I look into the Grand Knights' reports, I note the many charitable and educational endeavors being carried on by the Knights. All of these programs - wonderful in themselves - should be increased in intensity. I would suggest that in cooperation with the editor of MISSISSIPPI TODAY summaries of the various types of activities in all the Councils be summarized and presented occasionally to the readers of MISSISSIPPI TODAY.

You probably know that every Sunday and on great

feast days your Bishop is offering his Mass for all the people of Mississippi. A special place in my Masses and prayers is reserved for all the Knights and for their families. May God guide and inspire us. On your part, when the priest comes to that most solemn part of the Mass - the Eucharistic Prayer - you pray for Pope Paul and for your Bishop Joseph. I can assure you that both Pope Paul and myself appreciate your prayers as we face the heavy duties of our respective offices.

The State Deputy made his annual report to the Convention.

The report of your State Deputy for the 1971-1972 fraternal year is an account of my own stewardship combined with an evaluation of the status of the Order in the Jurisdiction.

On taking this office on July 1, 1971 your State Deputy was first of all bound to consider the suggestions, resolutions, and directions emanating from the Sixty-seventh State Council Convention in Natchez as guidelines for action. Some of these guide lines dealt with minor matters and others related to broad policies. Some of these suggestions could be acted up by the State Deputy. Others could only be implemented through the agency of State Directors and Chairmen or directly by the subordinate Councils in the Jurisdiction. Generally, some of these things were done, and some were not.

At the 1971 Convention the State Public Relations Chairmen emphasized the need for an active and positive public relations program in each Council. The Convention also authorized the expenditure of \$100 for financing publicity. While coverage in Mississippi Today during 1971-1972 seemed much more extensive than in recent years, it appears that most Councils have not followed through in a systematic manner. The authorized expenditure for paid advertising was not made because of the low level of the State Treasury.

Program suggestions were made at the last Convention by the Committees on Disaster Relief and on Social Justice, Social Peace. According to my records half the Councils in the Jurisdiction have not established local committees for these important activities and, so far as I know, no Council has actually initiated positive programs in these areas. Perhaps the reports of the State Chairmen will tell a different story.

At the Natchez meeting our State Chaplain suggested some worthwhile projects. Many Councils have followed-up by sponsoring programs related to vocations, a State-wide project recommended to all Councils. He also urged that we continue to move forward in implementing the policy that membership in the Knights of Columbus is open to all practical and exemplary Catholic men. An attempt was made to contact the Knights of Peter Claver with no practical outcome. Although I know of no case in this Jurisdiction like the recent incident in another Southern Jurisdiction, it seems clear that the Councils in Mississippi have not made any positive forward movement in this matter.

In his annual report last year Immediate Past State Deputy Norman Kiehm recommended the continuation of the Inter-Council Competition as an incentive to Councils to carry on full activities programs. This recommendation has been followed and the State Program Director's Report should reveal that it has been reasonably successful.

Other committees reporting last year suggested a number of ideas concerning youth activities, Catholic activities, membership, ceremonials, and the Good of the Order. These have generally been adopted as revealed in the Grand Knights' reports.

In evaluating the degree to which the objectives and ideals spelled out at the 1971 meeting have been achieved it seems clear that, overall, we have fallen short. It also seems clear that the task of achiev-

ing most of these goals is the responsibility of the leadership and the membership of the individual Councils because that is where the action is or should be. No amount of cajoling, reminding, suggesting, and urging by the State Deputy, District Deputy, or State Directors and Chairmen will get the job done. It takes commitment and dedication to the ideals of our Order by all leaders and members to carry out our adopted programs each year.

During 1971-1972 your State Deputy inaugurated a monthly newsletter to State Officers, Directors, Chairmen, District Deputies and Grand Knights. Its main purposes are to remind key personnel of programs and administrative responsibilities and to inform all concerned of developments of interest to the Order. Hopefully, this device has provided a useful communications link between the State Officers and the Councils.

Once again this year there was a threat of a new abortion law developing in the legislature. Your State Deputy sent letters in the name of the Order to the Committee Chairmen and other key officials involved expressing opposition to any relaxation of the existing law. Through the District Deputies each Council was asked to contact members of the legislature on this matter. The issue did not emerge from Committee at least partly because of the stand taken by the Knights of Columbus in the State.

One serious limitation on the operation of the State Council is a financial one. For example, funds have never been available to support the travel of State Directors and Program Chairmen thus reducing their potential effectiveness by denying them the opportunity to visit Councils and advise them on their respective programs. During 1971-1972 the financial straits of the State Council were such as to require a special resolution to increase the State per capita tax and the payment of an advance installment. Your State Deputy is appreciative of the support given by the Councils to this resolution

and for the subsequent prompt payment of the assessment. I would emphasize that expenditures were kept to a bare minimum, as the Treasurer's Report will reveal. A mimeographed State Directory replaced the customary printed form, no State Council stationery was purchased, and the Proceedings of the 1971 annual Convention were published at a lower cost than last year. Your State Deputy has submitted to the Resolutions Committee proposed resolutions concerning the per capita and mileage and per diem for 1972-1973. Such resolutions are necessary unless the State Council desires to abide by the provisions of the By-Laws of the Mississippi State Council.

The report on membership status will be left to the State Membership Director. During the year a monthly status report showing gains and losses was distributed to the Councils as a means of focusing attention on this vital matter. Overall, it appears that the Jurisdiction will not suffer any serious loss by the close of the year if efforts continue in conjunction with the Ninetieth Birthday Campaign and if retention efforts are given special attention.

The possibility of establishing new Councils in the Jurisdiction continues to exist. Your State Deputy has renewed the Tupelo project and has begun to explore the possibility of a College Council at the University of Mississippi.

Your State Deputy has from personal experience reached the opinion often expressed by your State Chaplain that Mississippi is a large area for one man to get around to all the places he needs to be. In addition to attending three meetings called by Supreme, I endeavored to visit as many Councils or Districts as possible within the time allowable from my other responsibilities. I especially expended some efforts in meeting with several Councils which have fallen into a period of temporary inactivity. I am hopeful that all Councils experienc-

ing a period of stagnation, for whatever reason, will resolve their problems and renew their full commitment to and participation in the programs of the Knights of Columbus.

At the opening session of this Convention a number of Committees were appointed to consider and to recommend programs and guidelines to be carried out in the upcoming fraternal year. I charge these Committees to take their responsibilities seriously and to present to the Convention recommendations in accordance with the ideals of our Order. I charge the delegates to this Sixty-eighth Convention to consider carefully such recommendations and to go back to their Councils and inspire their membership to strive to achieve the goals which we will set for ourselves here in Greenville.

In closing this report I would like to give my special thanks to those State Officers, Directors and Chairmen who have assisted in the work of the Order during this year. Special appreciation is also due to the District Deputies who are, of course, the key officers in the Jurisdiction.

# REPORT OF DISTRICT DEPUTY District No. 1

The Councils of District I have done very well this past year. The officers were duly installed in all three of the Councils in accordance with the new ceremonials. Councils immediately proceeded with the new Surge program and have been very good in carrying on the various activities recommended. Two of the three Councils could with very little additional effort be in line for the Star Award. The third is lacking only an increase of three members.

Overall membership status has progressed fairly well. The district as a whole has at present a 100% percentage for its membership quota. Forty new members have been taken in but the overall gain has been reduced by twenty-six suspensions leaving a net increase of 5% in membership, or the exact quota for the district. First degree initiations were held by all Councils and the district held one second and third degree initiations in Clarks-dale.

The records and financial condition of all Councils at present are in good order.

Cleveland deserves special recognition for achieving its goal of a new home, moving into it at the first of this term, the installation of officers ceremony being its first actual Council use.

District meetings have been held and fully participated in. Councils have entered into competitive events at the district meetings which have been enjoyed by those participating. I feel that the district meetings have become a looked for event and a spirit of brotherhood between the Councils is being developed. A step has been made toward members from one Council supporting social events of the others.

Hope remains for developing councils at Oxford and Tupelo and possibly Grenada, slight progress being made at Oxford and Tupelo.

Last year we only had two Star Council Awards presented in the state. To date, Clarksdale Council No. 2969 is the leader in new members invited. To date, May 1, 1972, this Council has recruited twenty-two new members.

From all reports it appears that the 1972 "Happy 90th Birthday" program was a tremendous success. Through April we have had two winners from Mississippi. I hope that Supreme will continue to promote this type of membership drives, and I would like to see the State Council start some types of membership promotion programs for next year.

A goal of 3,000 members was established for us this year, however we will fall short of this goal by about 350. If we continue to think membership and have the type programs that will attract new members this goal can be reached by the end of next year.

The State Deputy called on Rodney Sandoz for his report on the Service Program.

This year's Service Program was once again centered around the Inter-Council Competition Program. The program, which was started last year, is designed to promote Columbianism by generating a spirit of competition among the Councils of the state. Details of this year's program were finalized at a meeting of State Officers, Program Directors, and District Deputies held in Jackson on July 18, 1971. State Deputy La Forge sent each Council a copy of the program requirements on July 20, 1971.

Requirements for HONOR COUNCIL were very minimal. They included the filing of monthly activity reports and the completion of four activities in each of the four Service Programs - Church, Community, Council, and Youth Activities. The nature of these activities was left up to the discretion of each individual Council. This year we had ten Councils enter the competition. Of these six completed all of the requirements for HONOR COUNCIL. They were Meridian, Jackson, Vicksburg, Biloxi, Long Beach, and Green-wood.

To qualify for DISTINGUISHED COUNCIL, each Council had to first qualify for HONOR COUNCIL then complete each of the five statewide special projects. These projects were:

- 1. Sponsor a community-wide Drug Abuse program.
- 2. Sponsor a program on Vocations within the local parish.

3. Assist the local CYO organization.

4. Participate in a "Keep Christ in Christmas" program.

 Hold November Commemorative Services for our deceased members.

Again, each Council was permitted to use its own discretion as to how these projects could best be carried out in the community. The response by the participating Councils was excellent, particularly for the Drug Abuse program. Several Councils went all out and I feel much good was done in the name of Columbianism. Five Councils completed all the requirements for DISTINGUISHED COUNCIL. They were Meridian, Jackson, Biloxi, Long Beach, and Greenwood.

A special committee has been appointed by the State Deputy to judge the activities and scrap books of the DISTINGUISHED COUNCILS and pick the BEST SMALL COUNCIL and the BEST LARGE COUNCIL in the State. The winners will receive their trophies at the banquet tonight.

I think that this year's program was very successful even though only 10 of the 18 Councils of the State participated. The competitive spirit among the Councils was terrific. All of the participating Councils are to be commended for a job well done. I hope that next year we will see 100% participation in the program.

Directors for their diligence in sending me their

very interesting and informative and indicated that

CHURCH ACTIVITIES REPORT May, 1972

As Church Activities State Chairman, I have observed what could be called a "normal year."

Vatican II has generated numerous changes in the Catholic Church, and the Knights of Columbus are slowly bending toward these changes.

During this past year, the Supreme Council has supplied information and materials to the Church Activities Director of each Council. Some directors were enthusiastic and scheduled many activities. Some were not.

I am sure that poor attendance at Council meetings hindered the directors in developing interest in many of their activities.

In many Councils there still remains the problem of retaining an active Chaplain. An active Chaplain with an enthusiastic Church Activities Director could create a tremendous feeling between the Catholic Church and the Knights of Columbus.

The "Service Program" was initiated this year and it has great potential. I am looking forward to being a part of this program next year.

The State Deputy called on Robert Fratesi for his report on Council Activities.

In the Knights of Columbus today, it appears that the young and new members are rapidly losing interest in the organization. This is probably due to the lack of Council activity. And we know these young members will be the future of the Knights of Columbus.

This Committee strongly recommends that these new members be appointed to various Council functions, not as workers but leaders as well. Too many functions are designed to attract the older generation rather than young people. Committees should be designed with workers from all age groups, bearing in mind communication.

This Committee also recommends that more family participation be planned in the Knights of Columbus. Steps are being made to strengthen the Ladies Auxiliary throughout the state. It is the opinion of this Committee that the ladies participation will greatly strengthen our organization.

In reading the Grand Knights' reports from past years, this Committee finds that all Councils basically have the same functions throughout the year. We should have more of a variety to offer our Councils.

Last year's report mentioned that we should regroup within our Councils; this needs to be done as soon as possible. This Committee does not attempt to suggest any particular activity, for all Councils should evaluate their own needs.

The State Deputy called for the report of the Committee on Community Activities.

We, the Community Activities Committee, recommend that several specific activities be adopted for the coming year.

- 1. Drug Abuse.
  - Recognizing that the abusive use of drugs by individuals is a problem of major proportions in the United States, it is recommended that the Knights of Columbus, as an influential group of Catholic men, embark upon a state-wide program to combat this menace. It is therefore resolved that each Council adopt a program of drug abuse abatement patterned after one of those which has achieved some measure of success, and support or initiate this program through financial or active council support. Also, that the Knights of Columbus be aware and vigilant of trends to relax or repeal existing laws governing the use or possession of dangerous drugs, and exert its influence to defeat these moves. Also, that the Knights of Columbus, through its local Councils, provide support and encouragement to law enforcement agencies in their efforts to enforce the laws governing the use and possession of drugs.
- 2. The Knights of Columbus take a positive stand to denounce all abortion laws that are in force or under consideration, and that the Supreme Office take a positive approach toward testing the constitutionality of these laws which affect the destruction of human life. On the local and state level, each Council should embark upon a program to educate the community of the evils associated with abortion.

3. Recognizing that smut, pornography and morally objectionable movies are a chief contributor to the increase in crime among the youth of the nation, the Knights of Columbus should find an effective means of combating the presence of these evils through legislation and community educational programs.

Since the SURGE program offers the Knights of Columbus the means to participate and be recognized as an active participant in community affairs, each Council should embark upon an active program of involvement which encompasses every facet of community activity.

In order for these programs to be successful, each Council and Council member must lead the way in his community to exemplify Christian ideals and serve as an example of these ideals and principles to all of his associates.

- 10. Recommend names of Youth Program Chairman of each Council to be given to Father Cosgrove, Diocesan Youth Director in Jackson.

We would recommend that all Councils continue using the above programs.

The State Deputy called for the report of the Committee on Social Justice, Social Peace.

Of necessity this report will be very short for the very reason that we have very little information on which to report. I was appointed at the beginning of this fiscal year, State Chairman, by our Worthy State Deputy La Forge. All Grand Knights were asked to appoint a local chairman and to submit his name to the State Deputy. Only eight Grand Knights submitted names of their chairman and from this we

assume that the other ten did not set up this particular committee in their councils. The eight councils which did report the appointment are: Meridian, Jackson, Natchez, Vicksburg, Biloxi, Pascagoula, Long Beach, and Ocean Springs.

Halfway through the year I, as State Chairman, attempted to point out the importance of such a committee by writing to each Grand Knight, reminding the ones who had not appointed a chairman to do so, and asked each council to mail a report of their work in Social Justice so that a report could be given at the Convention. We received a reply from only two chairmen - that of Brother Leo Donelly of Meridian, Council 802 and of Brother Charles Pluff of Biloxi, Council 1244.

Meridian reports that their Social Justice Committee attempted in many ways to further the cause of social justice during the past year. Through the efforts of their committee the method for selecting the recipients of the three scholarships to the Meridian Junior College was changed. Previously, these three were limited to two white students from St. Patrick Church, and one white non-Catholic, all three of whom were selected by the Meridian School authorities. This year following the recommendations of the Social Justice Committee, the Council voted to extend the opportunities for scholarships to members of all three parishes in Meridian: Saint Patrick's; Saint Joseph's; and the Chapel of the Navy Base. Selection was to be made only on the basis of need, parish activities, and desire; and this year six instead of three, scholarships have been awarded. At least one recipient came from each of the three parishes. Two of the six winners are black, while four are white.

Biloxi's Chairman reports he attended a joint parish council meeting of the black and white parishes of his city, where various subjects were discussed, such as why no black cheerleader and no black K. of C. The Council has been running a

bingo for over a year open to all races. The Knights gave Father Marene SSJ, the pastor of Our Lady of Sorrows parish a purse when he was elevated to Vicar General of his Order.

As suggested by our Worthy State Chaplain,
I, as Chairman, attempted to contact by letter and
by phone, the District Deputy of the Knights of
Peter Claver in an effort to set up a meeting with
the Knights of Columbus. I had no success whatsoever. I then personally talked with Father Bourges
of Jackson, Supreme Chaplain of the Knights of
Peter Claver, and asked him to use the good graces
of his office to help in the setting up of such a
meeting, but here again no success was enjoyed.
Possibly this invitation should be extended again
at a later date.

This Committee will attempt to follow through on our Bishop's suggestion for an open forum next convention on the subject of "The Knights of Columbus and Social Justice." This should definitely be a great aid in creating more interest in this important subject and of pointing out the need of an active committee in each council.

It is impossible for the Committee to function separately because of a need for funds for telephone calls and correspondence in case of a disaster.

The Audit Committee met with the State Treasurer and reviewed the books for the past year, and found them to be in good order and commended Brother James L. Bolander for his efforts and fine record keeping.

We offer the following suggestions in an effort to maintain up-to-date and permanent records:

1. A central bank account with a bank in a central city be opened. All banking functions can be accomplished by mail from any city in the state, and as new treasurers are elected, only a signature change card would be required. This would eliminate changing banks every year or two years. It would provide a continuous

record of all bank transactions and help the treasurers in the performance of their office. Bank statements and check stubs would be uniform and easily stored for three years.

- 2. The present ledger book as established by the State Treasurer become permanent property of that office and passed on from treasurer to treasurer and left for a period of five years and then destroyed.
- 3. A reproduction of the State Treasurer's report be mailed to all Grand Knights within sixty days after the Convention, so that all members of all councils will know and realize the financial position of the State Treasurer.

  - a. Program Director
  - b. Membership Director

- c. Director of Church Activities
- d. Director of Community Activities
- e. Director of Council Activities
- f. Director of Youth Activities
- g. Disaster Committee Chairman
- h. Social Justice & Peace Committee Chairman
- 2. Complete between July 1 and April 15 any 4 projects in each of the following activities: Church, Community, Council, and Youth Activities (State Council Projects not included).
- 3. Submit a written report of your activities by the 15th of each month beginning Oct. 15 to the State Program Director.
- 4. Mail audit report to the State Deputy by Sept. 30 and Feb. 28.
- II. Distinguished Council

To qualify for the Distinguished Council Award each Council must:

- 1. Complete all of the requirements for Honor Council.
- 2. Must hold all state-wide projects as follows for 1972-1973:
  - a. Honor the Council's Past Grand Knights
  - b. Project to promote respect for law and order
  - c. All Councils must actively participate in disaster or poverty relief once a year in conjunction with the Chamber of Commerce or any local clearing house.
  - d. Must have an annual memorial service in November.
  - e. Assist the local CYO or a young adult group.
  - f. Organize an active vocations committee in the Council.

#### III. Best Council

To qualify as Best Small Council or Best Large Council each Council must:

- 1. Complete all of the requirements for Honor and Distinguished Council.
- Submit a scrapbook showing your Council's activities for the year to the State Convention for display, judging, and return.

#### Note:

If for any reason you are late sending in the monthly report, submit it to the District Deputy for certification. The District Deputy will then submit it to the State Program Chairman. Grand Knights are reminded that it is their responsibility to follow-up behind their chairmen to see that the reports are submitted.

The Statewide Program Chairman shall notify each Council what is required to qualify for Intercouncil Competition, within 30 days after his appointment as Statewide Program Chairman.

State Service Projects Committee hereby recommends the following statewide project: Knight's Crusade Against Cancer. This Crusade will consist of Knights of Columbus Invitational Basketball Tournament at Jackson to be held on or about Dec. 1 depending on the college schedule.

We propose to invite the 4 year colleges in the state to the tournament. Each council would be responsible for at least \$2.00 per council member to pay the expenses. Selling of the tickets to the event could relieve the council of the monetary obligation.

At the conclusion of each resolution, I shall indicate the recommendation of the Committee;

The State Deputy called for the report of the Financial Secretary's meeting.

The annual meeting of the Financial Secretaries of the Mississippi Knights of Columbus was held at Greenville, Mississippi on May 6, 1972.

The meeting was called to order at 9:30 A.M. by Sam C. Monistere, Financial Secretary, Greenville Council No. 2134, and with a prayer by Brother Nassar.

The first item of business was a discussion of Internal Revenue Service Form 990 (Return of Organization Exempt from Income Tax).

It was noted that this report must be submitted by all councils whose gross receipts total \$5,000 or more; that it must be submitted on or before May 15, by all councils, required by law to do so; that councils who have not filed by the required date will be subject to a penalty of \$10 per day for each day late up to a maximum of \$5,000. Brother Monistere explained in sufficient detail the requirements of the report, especially the items of information which the Financial Secretaries and Treasurers would need to provide for the proper completion of the report. It was agreed that the responsibility of filing the report is that of the Grand Knight with the cooperation of the Trustees, the Financial Secretary, and the Treasurer.

The matter of delinquent membership accounts was discussed. Following are some of the observations made by the Financial Secretaries attending the meeting:

- 1. Each Financial Secretary should be familiar with his Council's membership in order to properly administer the finances of his Council.
- 2. The Financial Secretary must use good judgment, be diplomatic and tactful.
- To reduce delinquencies, he must exercise a follow-up program.
- 4. No suspensions are to be made without the prior approval of the Grand Knight and Trustees.

Each Financial Secretary was given the opportunity to relate how his council handled the matter of delinquent accounts with the consensus being that each case brought before the Grand Knight and Trustees should be handled on its merits, keeping in mind by-laws governing these matters.

On the matter of the Semi-Annual Audit Report, it was noted that some councils still persist in making the preparation of this report the responsibility of the Financial Secretary and Treasurer. The Financial Secretaries wish to go on record as pointing out that this is the prime responsibility of the Grand Knight and Trustees in order for the report to be meaningful and in keeping with its purpose.

The matter of the Traveling Card came up for discussion primarily brought about by the question of its effectiveness as a means of control at closed meetings. It was the consensus of those present that, generally, the Council Warden seldom takes enough time to carefully scrutinize the card for the tell-tale dates indicating paid up status and the travel card year; or that the card properly bears the council seal; or that it is properly signed.

On a motion by Gus Ward and a second by Fritz Oberlies, the Financial Secretaries request the State Deputy to submit a resolution to Supreme Council stating that it would be desirable to change the color of the traveling card each year, pointing out that this would be an effective means of detecting delinquent members. The motion carried unanimously.

It was noted that Financial Secretaries should be alert to the possibility of issuing a Third Degree travel card to a member entitled to First Degree membership privileges only.

A general discussion on membership followed. It was noted that in all cases the Financial Secretary, with the assistance of the Grand Knight, should periodically up-date the council's membership roster. It has been noted, also, that the membership roster provided by Supreme Council semiannually should be carefully scrutinized and purged of members not rightfully appearing thereon. Mistakes most generally noted on Supreme Council's roster are such things as duplication of members' names, incorrect birth date, incorrect entry date, etc.

There being no further business to be brought up, the meeting was adjourned at 11:05 A.M. with a prayer by Brother Oberlies.
