# PROCEEDINGS OF THE 76TH ANNUAL STATE CONVENTION MISSISSIPPI STATE COUNCIL KNIGHTS OF COLUMBUS

# Friday, April 25, 1980

The 76th Annual State Convention of the Mississippi State Council, Knights of Columbus was convened at 6:00 P. M. with Grand Knight Danny E. Hillhouse of Council No. 4654 presiding. Grand Knight Hillhouse welcomed the convention on behalf of the Greenville Council and Brothers Frank Greco and James Wuestenhoefer Convention Co-Chairmen. He then introduced Mayor Bill Burnley who welcomed the Knights of Columbus to the City of Greenville.

Grand Knight Hillhouse then introduced the Chief of Police Brother Robert Skinner who also welcomed us to the City of Greenville.

State Secretary Don Oldmixon responded on behalf of the State Council after which Grand Knight Hillhouse turned the gavel over to State Deputy Rodney Sandoz who officially called the convention to order.

State Warden Dennis Ladnier, Sr. and his assistants checked current membership cards and vouched that only qualified Third Degree members were present. State Chaplain Frank Corcoran was called upon to lead the opening prayer. Following the prayer the members present pledged allegiance to the flag.

After requesting cooperation of the convention to expedite the business at hand, the State Deputy introduced the other State Officers and then passed out the printed Order of Business. He then called upon the delegates present to turn in their credentials to the State Secretary; and that the Grand Knights turn in any resolutions to State Advocate Wiley Price, Jr.

recipient was the Honorable John C. Stennis. 6. Provided the Knights of Columbus home as a hurricane shelter during the aftermath of Hurricane Frederick. Knights manned the home continuously during

the period that it was utilized by the evacuees from the coast.

Our guests were seated at splendidly set and decorated tables arranged by the Ladies Auxiliary. We were honored to have as our guest speaker Past State Deputy Hilton Seymour. As highlights, a mortgage burning ceremony was held, signifying our Council's new debt-free status and the presentation to Mayor Dale Danks of a plaque recognizing his outstanding contribution to the Jackson community.

HURRICANE FREDERIC - Our Council presented a check for \$500.00 to Bishop Howze, Catholic Diocese of Biloxi Hurricane Frederic Relief Fund. This money represented the proceeds from one night of Bingo and donations from several of our members and friends of the Knights of Columbus.

# ANNUAL STATE DEPUTY'S REPORT 1979-1980

My Brother Knights,

As I stand before you today to give an account of the status of the Knights of Columbus in the State of Mississippi and my stewardship as your State Deputy, I am reminded of those who have stood in this position before me and the many great achievements that have been made in our state in past years. When you elected me one year ago, I pledged to do all that I could to carry on this fine tradition and to see that Mississippi continued to grow in the spirit of Columbianism.

The first months after the election but beofre actually taking office were busy ones for me as I finished my duties as State Secretary by compiling the minutes of the 75th Convention and began to put together a team of District Deputies and State Chairman who would be dedicated to carrying out the goals of the Knights of Columbus. I think that the team we have today is an outstanding group of Knights and I thank each of them for all the work they have done during this fraternal year.

In June I attended a State Deputies' workshop in Clearwater, Florida at which was outlined the Supreme Council's program for the coming year. At this meeting Supreme Knight Virgil Dechant reminded each of us that the primary duty of a State Deputy is to insure that the Knights of Columbus remains truly Catholic in each jurisdiction and at all times upholds the proud title of "Right arm of the Church". I can truly say that we in Mississippi are doing this.

The installation of state officers was conducted by Bishop Howze in Long Beach the weekend of July 7 - 8. During this weekend an orientation meeting was held to familiarize the State Officers, District Deputies, and State Chairmen with the details of the program outlined in Clearwater. This meeting was well attended and each of us came away with a renewed enthusiasm to promote the cause of Columbianism in out state.

In August, I was privileged to attend the 97th annual Supreme Convention held in San Diego, California. Attending with me were my wife Josie, Past State Deputy Dave Atteberry, State Chaplain Father Kelleher, Brother Nassar of Greenwood, and several members of the Biloxi Council including Past State Deputy Hilton Seymour. I have many fond memories of this Convention, but the highlight was the announcement by the Supreme Knight that Mississippi had captured the first place position in Division V of the Order's membership program thus making Past State Deputy Atteberry eligible for an all expense paid trip to Rome. This is truly significant when you consider that this is the third time in six years that Mississippi has been so acclaimed.



During the convention Mississippi was again honored as Grand Knight Ricky Nause of Hattiesburg was picked as one of only ten Grand Knights in the entire order to accompany the winning State Deputies to Rome. But this was not all. Each and every district in the state met its membership quota and fourteen of our twenty-five councils achieved Star Council status.

At the close of the convention I was presented with a portrait of Our Lady of Guadalupe and was requested, as were the other State Deputies, to take this portrait back to our home states and have it circulated from council to council for a special hour of prayer to Our Blessed Mother. This portrait, specially blessed by Pope John Paul II, has circulated through many councils already and I am certain that the devotion shown to Our Lady by the many thousands of persons throughout the state will bring God's blessings on our families, our councils, our state, and our nation. I thank each of you who have worked to make this project a success.

This year we initiated the "Magnolia Knight" newsletter to keep the councils of the state informed as to what is happening in the state. This newsletter which is put out monthly goes to all State Officers, District Deputies, State Chairmen, Grand Knights and other key council officers and chairmen. It is a vehicle by which we can communicate with each other regarding items of news that are important to the programs in out state. Each of you is urged to contribute articles of interest as often as you can. I thank State Secretary Don Oldmixon and Public Relations Chairman Leo Ridge for their dedicated efforts in making this newsletter interesting and relavent. They have put in many long hours on this very special project.

Insurance is an important part of the over-all Knights of Columbus program and we now have a resident Mississippian directing this facet of Columbianism. General Agent Roy Powers has been criss-crossing the state promoting the insurance program with great results and in his many travels he has made several contacts in places where we hope to establish new councils. These contacts will bear fruit in time and we trust that within short order we will see the establishment of new councils in several other towns and cities across the state.

At the beginning of my term of office I set as a membership goal the addition of one new member for each day of the year using as our theme "EACH ONE REACH ONE-A KNIGHT A DAY". Admittedly this was an ambitious goal but one I truly thought could be attained in light of the achievements of the previous years. I wish that I could report to you today that we are on target, but with 275 days already over through the month of March we have brought in only 185 new members. We do have a long way to go. We must try harder.

One of the tougher duties I have had as State Deputy was the writing of so many letters to members in danger of suspension from our Order. To date I have written 164 such letters in response to Notices of Intent to Suspend and while this is not a pleasant task, I regard it as a most important one because it has given me an opportunity to explain the value of the Knights of Columbus for one last time to those who for whatever reason have lost interest in our cause. I feel that this program has been successful because of the 164 I have written to, 97 have reconsidered and kept their membership and the majority of those who did not were those who had moved to other states.

Recruitment of new members as well as retention of existing members is vital to the growth and stability of our Order and both topics will be covered more fully by the respective chairmen as this meeting progresses.



I would like to make mention of the tremendous effort made by our councils in last year's Tootsie Roll Program to aid the mentally retarded. Because of your efforts and the matching Federal Funds these unfortunate Mississippians received over \$300,000 in financial aid. I will leave the details to Dave Atteberry but I strongly urge each of you to work to make this year's program even better.

In December I attended a workshop for State Deputies in Corpus Christi, Texas. The program for the second half of the fraternal year was outlined at this time and we have demonstrated to us the proposed new First, Second, and Third Degree ceremonials. These new ceremonials are in the process of being refined and will probably be introduced later in the year. They are very impressive and require much participation on the part of both candidates and members. In the meantime we will continue to use the present ceremonials and I wish to thank Past State Deputy Seymour and the Biloxi Degree Team for the fine degree work they put on for us in Picayune, Meridian, Pascagoula, and Clarksdale. We hope to have another exemplification in the Natchez area in the very near future.

Our mid-winter meeting was held in Jackson this year and it too was well attended. The Jackson council as usual was a most gracious host. At this meeting I regretfully announced the resignation of Father Michael Kelleher as State Chaplain because of his many pressing pastoral duties. Father Kelleher served the state faithfully and well and his services are much appreciated.

After consultation with the other state officers and district deputies, I prevailed upon Father Frank Corcoran of Greenville to accept the post of State Chaplain. Father Corcoran is known to many of you for his many years of dedicated service to the Knights of Columbus and we welcome him as State Chaplain and look forward to a long and fruitful assocaition.

The Bishop Greco Membership Program ended in December at which time we had added 128 new members to our ranks in honor of this great native Mississippian. In connection with this program each district deputy and grand knight was eligible for a chance to win an all expense paid trip to Disneyworld provided they achieved the membership goals set by the Supreme Council. Three of our district deputies and five of our Grand Knights were eligible for the state's drawing. District Deputy Richard Benton and Grand Knight Nick Wagner were our states' winners. Brother Wagner was chosen by the Supreme Council as one of the 10 national grand knight winners and he and his family will receive a trip to Disneyworld. The membership campaign for the second half of the fraternal year honors Pope John Paul II and once again there are a number of fine prizes for those who participate.

In January we had a very unique opportunity to publicize the works of the Knights of Columbus in Mississippi. We were the guests on three one-half hour segments of the "Faith of Our Fathers" program aired on WLOX-TV. These programs beamed throughtout South Mississippi on three successive Saturday eveings were designed to spur an interest in the Knights of Columbus. The first program outlined the mission and goals of the Order in Mississippi and featured a discussion of how the Knights are a relevant force for the promotion of Christian ideals and family participation in Church and community. The second program dealt with our contributions to the fostering of vocations and the third dealt with our state-wide Tootsie Roll Program to aid the mentally retarded. It is impossible to estimate the true value received from these programs. The costs would have been substantial if we had to pay for this TV time. I have had many people say that they thought the programs were excellent and gave them a glimpse of the Knights of Columbus they had not realized before. Several of them have since sought to join our Order.

This year marks the tenth anniversary of our state's Intercouncil Competition Program. In reflecting back over these years we note that this program has grown from very modest beginnings to a point where today it is participated in by almost every one of our councils. It is a program that has spurred a spirit of friendly competition among the councils and has caused Columbianism to spread throughout Mississippi. I appreciate each council's efforts in regards to this program and I commend State Program Director Mike Leleux for his able administration of the programs. Brother Leleux and the other state directors and chairmen will be reporting on this and the other State programs and I don't want to steal too much of their thunder at this time.

In the area of new council development we were able to bring about the formation of a new council in Philadelphia thus bringing our total number of councils to 26 in the state. We are hopeful that there will be one or two more additional ones added before the end of the year.

I was privileged this past year to attend a number of council functions across the state, not as many as I would have liked, but as many as time and circumstance would permit. In each council I was met with fond remembrances and I thank all of you for your kind invitations. My wife Josie and I will always treasure the many acquaintances we have made this past year and hope that we can continue these friendships throughout the years.

In conclusion I want to thank my fellow State Officers, District Deputies, State Directors, and State Chairmen for the help you have given me this past year. It is only through your generous contribution of time and talent that we have been able to see the Knight of Columbus grow and prosper in Mississippi. It is your dedication to Columbianism that has made possible whatever achievements were made this past year. No one man could do it all and I would certainly have been lost without your help and advice, and for this I am truly gratefull.

The Knights of Columbus is a vibrant organization in the State of Mississippi. Through our many programs we have been able to help in the spread of Christ's gospel message to love one another. By the practice of the great principals of our Order-Charity, Unity, Fraternity, and Patriotism-we prove daily that we are truly the finest Catholic, Family, Fraternal organization in the world. It is awe inspiring and truly humbling to have been chosen to lead this fine organization the Mississippi Knights of Columbus. I thank each of you for this tremendous opportunity you have given me to serve as your State Deputy. I am truly gratefull. Vivat Jesus!

It was with pleasure that I read in the last newsletter that we would have a display booth on Pro-Life set up here at the convention.

I ask you again here today to please let President Carter know how you feel about the abortion issue. Ask that he nominate men and women who care for and respect all human life, both unborn and born, as replacements for Justices of the Supreme

It was reported in the publication "Court" that watchers predict Justices Thurgood Marshall, age 71, and Lewis Powell, age 72, will join William Brennan in

retirement" at the end of the summer of 1980.

I have written letters to HEW Secretary Patricia Harris urging her not to fund in-vitro fertilization. In-vitro fertilization (creating so-called "test tube" babies) is a procedure by which human beings are conceived in a laboratory. I understand that the clinic was approved; and to date, thay have had no luck in the fertilization of an embyro at the Norfolk, Virginia clinic.

## REPORT OF THE "BISHOP GEROW MEMORIAL FUND" 1979-1980

It gives me a great deal of pleasure to announce that we have again gone "over the top" from the previous year for the "Bishop Gerow Memorial Fund". Our total collected this year is \$19,471 which exceeds last year's quota by \$4,370. This brings out over-all grand total to \$213,242 since this fund was started in 1953 with a donation of \$125 from each of 4 Councils.

I am sure that most of you know that this money is given to the Bishop of the Diocese in which the Council is located for the education of future priests in

Mississippi.

Most Reverend Joseph B. Brunini, Bishop of the Diocese of Jackson received \$8,455 and Most Reverend Joseph L. Howze, Bishop of the Diocese of Biloxi received \$10.866.

The Long Beach Council should have a special mention because they actually raised \$2,000 towards the education of future priests, however, \$1,100 was given to the Vincentenian priests who have served their parish for many, many years and \$900 to our fund. Vicksburg, Greenville, and Gulfport were in the high brackets.

The Pascagoula Council is to be especially congratulated upon its most generous contribution of \$6,500.

In general all of the Councils increased the donations. The Seneca Council

## RECRUITMENT & RETENTION REPORT

As of April 1, 1980, Mississippi has gained 185 members and lost 88 members for a net of 97 gained to put us in seventh place in Divsion V of the national standings.

Five Councils show a decrease in membership, six councils show no change in membership, and fifteen councils show an increase in membership. More emphasis definitely needs to be placed on the importance to the councils of actively seeking new members.

Presently, the state membership stands at 3544. This is the highest that your membership has ever been. For you information each time the State of Mississippi adds one new member, we break our own state total membership record.

Brothers, one of the best methods to masure the progress of a state or local council is by membership gain or loss. Do things right and you attract new members. Do them wrong and you lose. It's just that simple.

We recommend that we go back to our own councils; improve and increase the activities of those councils to where we are proud of them, and then ask other fellows to join with us to do the important work of the Knights of Columbus.
