# PROCEEDINGS OF THE 77TH ANNUAL STATE CONVENTION MISSISSIPPI STATE COUNCIL KNIGHTS OF COLUMBUS

## Friday, April 24, 1981

The 77th Annual State Convention of the Mississippi State Council, Knights of Columbus was convened at 6:00 P. M. with Grand Knight Wiley Price, Jr. of Council No. 802 presiding. Grand Knight Price welcomed the convention on behalf of the Meridian Council. He then introduced Mayor I. A. Rosenbaum who welcomed the Knights of Columbus to the City of Meridian.

State Secretary Don Oldmixon responded on behalf of the State Council after which Grand Knight Price turned the gavel over to State Deputy Rodney Sandoz who officially called the convention to order.

State Warden Dennis Ladnier, Sr. and his assistants checked current membership cards and vouched that only qualified Third Degree members were present. State Chaplain being delayed, the State Deputy called upon the Immediate Past State Chaplain Fr. Michael Kelleher to lead in the opening prayer. Immediately following prayer the members present pledged allegiance to the flag.

## JOHN T. SAVAGE COUNCIL #848 Jackson, Mississippi

The following is a report on the activities of the John T. Savage Council No. 848, Jackson, Ms. for the year 80-81.

#### CHURCH

- 1. First Friday services are held each month in the St. Dominic hospital chapel.
- 2. Members serve as Lay Ministers, Lecturers, Commentators, Ushers, and Gift Bearers for the nine parishs of Jackson.
- 3. Keep Christ in Christmas bumper stickers were placed on members autos.
- 4. Corporate communion is held in each members parish quarterly.
- 5. A Day of Recollections was held in the council home.
- 6. A program of fellowship and a dinner for the religious community of Jackson was held at the council home.
- 7. A Memorial service for all deceased Brothers was held by the council.
- 8. A 65th anniversary mass with coffee after was held at St. Therese church for Brother Ruwaldt. Brother Ruwaldt completed his 65th year as a Knight on Dec. 7, 1980. His home council is in Oklahoma.
- 9. The council presented a plaque to Father Balser for his services to the council and the community on his 25th anniversary as a Priest.
- 10. The 4th degree honor guard members have supported the parishes during masses at Christmas and during the two anniversary masses.
- The Church of God holds its services in the council home every Saturday morning.

## COUNCIL

- 1. Every Saturday night a steak supper and bingo is held to help support the council.
- Every first Tuesday a covered-dish supper, with the meat provided by the council, is held in the council home. After many of these suppers special programs were apresented for the Knights and their wives.
- 3. Every fifth Tuesday, a game night is held for all members and their families.
- 4. A New Years Eve dance was sponsored by the council.
- 5. Blood has been donated when needed by members.
- 6. Two teams were sent to the bowling tournament in Pascagoula.
- A newsletter is mailed to all members and other interested persons ten times a year.
- 8. The council sponsored a Formation and Knighthood degrees in March and have conducted admissions degree initiation throughout the year as needed. The 2nd and 3rd degree initiation caused a loss of about 150 dollars to the council. Because of the

high cost of housing the initiation team, the council recommends that the District Deputies sponsors all 2nd and 3rd degree initiations when the team must stay overnight, with the cost split by the councils in the district or districts if two or more District Deputies sponsors the initiation.

- 9. This year's Tootsie Roll Drive raised near 5300 dollars for the mentally handicapped. The Jackson, council believes that more money could have been raised in May and that the drive being moved to April hurt the final results because: 1. The firemen were holding their drive for the burn center, 2. The number of people going to the reservoir was reduced, 3. The AmVets were selling poppies, 4. The rain kept some workers off the streets. The Jackson council recommends that each council be allowed to set its own dates for the Tootsie Roll Drive within a set period of time (ie. 1 April to 1 June) because the councils know their communities and could plan for a more productive drive. The insurances could be written in such a way to allow for random dates provided the councils give the State Deputy its dates before a cut-off date (ie. 1 February).
- 10. The mid-winter state meeting was held in Jackson in December.
- 11. The council's Ladies Auxillary is very active in all activities and the relationship between the groups is outstanding.
- 12. A spaghetti dinner and bingo will be held on May 31, for the St. Judes rebuilding fund. St. Judes church was destroyed in Jan. 81 by fire.

#### COMMUNITY

- 1. Members provide transportation for blind members to council and church activities.
- 2. Christmas baskets were provided to needy families.
- 3. Members kept score for the handicap bowling tournament, provided needed help at the special olympics, and assisted with their Christmas dance.
- The council sponsored Fourth of July and Labor Day programs for all friends of the council.
- 5. The council provides funds to support the Pro-Life booth at the Mississippi State Fair.
- 6. Members assisted the Salvation Army in its Christmas fund raising drive.

## YOUTH

- 1. A football bowl game between league champs within Jacksons grade and private schools was held in November. The bowl game supports the councils scholarship program.
- 2. Local and state-wide basketball free throw contests were held in Jackson.
- 3. Co-sponsored with the Ladies Auxillary the children Christmas party and the Easter egg hunt.
- 4. The council has provided funds and time to the local CYO's and to the REACH program.

## FAMILY

- 1. Provided names to Supreme for its Family of the Month program.
- 2. Deceased wives of Brother Knights participate in many of the council activities.

- 7. The Brothers of our council assisted the Garden Clubs of Natchez by participating in the Natchez pagent held four nights a week for the month of march.
- 8. We also promote citizenship by having many of our members in political office.

  9. We again participated in the statewide Tootsie-Roll drive for the mentally
- 9. We again participated in the statewide Tootsie-Roll drive for the mentally retarded children.
- 10. For the seventh year in a row we sponsored an open softball tournament to raise money to send our two softball teams to the State K. of C. Tournament.

## PERE LE DUC COUNCIL NO. 1522 Bay Saint Louis, Mississippi

The Knights of Columbus, Pere Le Duc Council #1522, instituted Sunday, December 18, 1910 and which celebrated its 50th Anniversary, its Golden Jubilee, as one of the most active and meaningful Councils in the State of Mississippi in the year 1960, found itself slowly deteriorating, and from 1966 onward, for approximately fourteen years, became virtually stagnant with no significant effort to develop any programs for membership, Church, youth, community, or family. Serious consideration was given to the cancellation of this Council's Charter. A choosen few leaders from the State and local levels were determined not to permit this to happen.

In July 1980, elections were held which resulted in new officers being installed. They were: Bob Hubbard, Grand Knight; Tony Scavo, Deputy Grand Knight; Father Francis Farrell, Chaplain; George DiBenedetto, Treasurer; George Hammer, Recording Secretary; Joe Benvenutti, Financial Secretary; Joe Richardson, Chancellor; Donald Ladner, Advocate; Lionel Baxter, Warden; J. Norton Haas, Inside Guard; Tony Morreale, Outside Guard; Bob Goodsell, Trustee (1); Noel Fuente, Trustee (2); C. J. Piazza, Trustee (3).

The above Officers were installed on July 15, 1980, at a beautiful banquet with Bishop Howze as guest of honor; State Deputy Rodeny Sandoz; District Deputy Bill Seal, and their wives, and more than fifty couples in attendance. The attendance and the enthusiasm shown at this affair proved that the spirit of the Knights of Columbus was still alive in this Council.

This marked a new beginning for the Pere Le Duc Council and under the leadership of its new Officers the effort for new members and activities were instituted.

A total of seventy-nine Knights were initiated into the second and third degree, nineteen of those from Pere Le Duc Council #1522.

On behalf of the officers, past and present, as well as the men of our Council, it is indeed a pleasure to offer this report on the Hernando Desoto Council No. 7120, located in Southaven, Mississippi.

Following last years convention, Grand Knight James Higgins returned to Southaven excited and determined to make the final days of the 1979 - 1980 fraternal year highly successful, so that the incoming officers would have a sound base on which to launch the 1980 - 1981 fraternal year. In this regard, the Council conducted its' annual Tootsie Roll Drive with higher goals and greater enthusiasm than ever before. The net result was an increase of \$2,300.00, or 250%, over the previous years gross receipts. #### ANNUAL STATE DEPUTY'S REPORT 1980 - 1981

My Brother Knights,

This is the second time I have been privileged to stand before you and give an account of the status of the Knights of Columbus in Mississippi. Since last we met in convention in Greenville much has happened in the spread of Columbianism across this great state of ours. Each of you can be justifiably proud of the many noteworthy events that have occurred this past year.

Our fifth annual Tootsie Roll Drive to raise funds for the mentally retarded was conducted the week-end following the convention. This successful drive under the able leadership of PSD Dave Atteberry grossed over \$70,000 which is the highest amount since the program began. These contributions which were distributed throughout the state helped many of our less fortunate citizens to a better way of life. Our efforts were recognized by the Mississippi Association of Retarded Citizens when they named us the "Outstanding Citizens Group" and presented us with a plaque attesting to this fact.

In June, Josie and I were privileged to attend the State Deputies' meeting in New Haven, Connecticut. I can truly say that this was a personal highlight of this fraternal year. Every Knight dreams of seeing the birthplace of Columbianism and visiting the

Supreme Council Headquarters. During our visit we attended Mass at the gravesite of the founder of our great Order, Father Michael McGivney. This awe-inspiring occasion reminded us of the vision of this gentle young priest who founded an order of Catholic men which has grown over the years to the mightiest such organization in the entire world.

While in New Haven we attended the dedication of the Knight's Family Chapel in the Supreme Council building. This beautiful little chapel serves as a daily reminder that the Knights of Columbus has become more than just a Catholic Men's organization. We are truly family-oriented.

During our meeting we received presentations outlining the Order's programs and each State Deputy was given an opportunity to set goals for his jurisdiction. The goals set by me for Mississippi are well on their way to fullfillment, thanks to the efforts of each and every council in oru jurisdiction.

Today we stand Number One in Division V for membership and with a little luck and some more effort we hope to finish out the year on top. To date we have added 291 new members to our councils in Mississippi and are only 69 short of our projected goal for the year. This should be easily attainable if each council will continue the good work from now thru June.

On the other side of the coin however, we have lost 132 members due to suspensions. As always this continues to be a problem. I urge each council to try harder to retain their membership and do all in their power to avoid further suspensions before the end of the fraternal year. It is only thru the retention of membership that we will be able to hold on to our Number One position.

As of today we have 12 councils that are eligible for Star Council Status with 6 other councils well on their way toward meeting their goals. Last year we had only 5 councils which merited this distinction.

I congratulate last year's winners of the Contest of Champions awards - Clarksdale with the greatest net gain in membership and Kiln with the highest percentage gain. This year's contest is a real horse race with a number of councils vying for the honors.

Our installation of State Officers was held in Long Beach on the week-end of July 12 and 13. The meeting was well attended and was designed to acquaint our State Officers, District Deputies, and State Chairmen with the details of the programs outlined at the State Deputies meeting in New Haven. The enthusiasm generated at this meeting has helped to make this year's program successful.

During July, I traveled extensively to a number of councils to participate in their Installation of Officers ceremonies. The hospitality shown by each of these councils will long be remembered.

In August we attended the 98th Supreme Council in Atlanta, Georgia. Mississippi was well represented at the convention since it was within driving distance. The highlite of the meeting was the announcement that the Bassfield Council had been chosen as the winner of the Best Church Activity in the entire Order. I can think of no greater honor that could be bestowed on Mississippi than to know that one of our own councils had been picked in this most important category. This is a significant achievement for such a small council in a predominantly Protestant state to conduct a Church Activity deemed "Best" over all the other jurisdictions. Grand Knight

Walter Daley and his wife Rachel were guests of the Supreme Council as recognition of this achievement. They and the other members of the Bassfield Council deserve our sincere appreciation for a job "well done".

In December I attended the State Deputies Meeting in Chicago. At this meeting we were told of plans for our upcoming Centennial celebrations and shown the final revised ceremonials of the Order. This meeting was followed by our own mid-winter meeting held in Jackson Sunday December 14. At this meeting we outlined plans for the second half of the fraternal year.

As all of you know, each council was encouraged to form a new First Degree term to exemplify the new cremonials. This team must be in place before the end of June, at which time the old ceremonial First Degree will no longer apply. PSD Hilton Seymour and the Biloxi Degree Team is in the process of putting together the new Second and Third Degrees which must be in place before the end of December.

During our mid-winter meeting, Mississippi was chosen with several other jurisdictions to participate in a pilot Vocations Program designed to create a greater awareness of the current vocations cirsis and involve each council on a personal level with candidates for religious vocations. It is too soon to determine the success of this pilot program, but I am hopeful that the outcome will be favorable.

In connection with our Centennial celebrations for the coming year, I have appointed Tom Zettler of Meridian as our State Centennial chairman. He will serve in this position through October 1982. The Supreme Council has a number of programs planned to celebrate this historic occassion including promotion of the cause of sainthood for Father McGivney. Brother Zettler will be outlining the plans we have for Mississippi when he delivers his report, so I won't go further at this time.

The theme of the second half of our fraternal year has been "Back to Basics." The thrust of this program is to have each council participate in those basic programs of the Order which have proven so successful over the years. These programs if engaged in enthusiastically will help greatly in the spread of Columbianism.

One of the basic programs that has been most successful in our jurisdiction has been the Inter-Council Competion which is in its eleventh year. This year we added a membership goal of 5% net increase for each council wishing to attain Distinguished Council status. At first this seemed like a very difficult goal but 12 of our councils have already met or exceeded this goal. Program Director Mike Leleux has done an outstanding job administering this program, and I will leave further details to his report. I would like to say however, that I believe that this program has matured over the years to a point where I think it is time for a change in name. I suggest that from here on out it be called the Knights of Columbus Honors Program because while each council does complete with each other to be named "Best Council", the honor of being named Distinguished Council denotes a high standard of excellence which can only be measured by individual council achievement. I trust that at this meeting we will ratify such a name change or one similar to it.

This year we have seen increased participation by our councils in the "Family of the Month" program. This program gives us an opportunity to recognize outstanding families on the local level. To date six Mississippi families have been chosen in the Supreme Council "Family of the Month" drawings. Each family received a beautiful plaque depicting the Holy Family to comemorate their winning. I urge those councils not presently involved with this program to give serious consideration to participating in the future.

Throughout the year we have held six Second and Third Degree Exemplifications across the state. I was privileged to attend all but the one held in Jackson which I was unavoidably unable to attend. It was a real privilege to see over two hundred brother knights receive the honors of these degrees. I trust that I will be privileged to see at least one or two more before the end of my term of office.

One of the major disappointments of the past year was that we were able to develop as many new councils as we had hoped. This was not due to any lack of effort on the part of New Council Development Chairman Roy Powers or our District Deputies. Each of them followed up on every lead. Some of these leads seemed very promising at times but the time must be right if a new council is to be started. The groundwork has been laid and I am certain that we will see a number of new councils in the next year or two.

We are pleased to welcome the Pass Christian delegation to this convention. Pass Christian was reactivated this year after considerable effort on the part of District Deputy Bill Seal.

It has been my privilege to attend many social events and meetings of councils all over Mississippi this year. I thank each of you for your gracious invitations and hospitality. I particularly wish to thank my fellow officers, District Deputies and State Chairmen for the help given me as they carried out their assigned duties with such care and concern this past year. If our programs are successful it is due to their dedication and the dedication of countless Knights in our jurisdiction who have thought enough of our great Order to promote the many good works that have been done in the name of the Knights of Columbus. No one person can do it alone. It takes team effort and spirit, and I think the Mississippi Knights have both.

I also want to thank my wife Josie for her help this past year. Her inspiration and words of encouragement and her patience with the many hours spent in carrying out my duties is deeply appreciated.

This past two years have been exciting for me. The rewards that come from helping to spread Columbianism cannot adequately be measured in human terms. To know that we are part of a great organization whose programs help spread Christ's gospel message of love is in itself a great reward. To be chosen to lead such a fine organization is indeed a great honor. I thank you for having given me this opportunity to serve as your State Deputy. It is one which I will deeply cherish and always remember. I am truly grateful. Vivat Jesus!

I also attended the District Meeting at Bay St. Louis with State Deputy Rodney Sandoz and Bill Seal the district's District Deputy. I was also in attendence at the Pass Christian Councils Meeting giving some aid to the new councils Programs committemen. I attended Knighthood degrees at Biloxi and Lumberton during the year.

I have gotten to know many of you, and had been given the opportunity to learn by action what Columbianism is in the Mississippi Knights of Coumbus. To our State Deputy Rodney, I certainly thank you for the opportunity you gave me by appointing me to this position, and thank you brothers of the state Knights of Columbus for all of your help.

In closing let me say the Knights of Columbus is a great organization. The good we do threw our programs are examples of this fact. Weather the program is the Tootsie Roll campagne, Free throw Campagne, aiding any number of charities from the St. Jude Hospital to the United Way, assisting the Elderly in Convalesent Homes, Helping a Church to completely refurbish the church from top to bottom or aiding the KC' local CYO. The Knights of Columbus was there. Brothers you where there, because brothers, you are the Mississippi Knights of Columbus.

## REPORT FROM PROGRAM DIRECTORS MEETING

- 1. To change the name of the Intercouncil Competition program to the Mississippi Knights of Columbus awards program. The reason is clear that the councils who participate in the program are really competing against themselves, more than any other council. The State council is really giving awards on councils accomplishments, not competitive accomplishments.
- 2. The method of judging, be changed, to a point system. Where the councils accomplishments will be judged on all projects rather than prescribed, with exception of the mandatory projects which are found in the distinguished council qualifications.
- 3. The method of judging the best small and large council be by a total point basis, based on the point system outlined with this suggested list of changes.
- 4. That the method of reporting be changed to one report a year and that be taken off the Grand Knight's report which has to be submitted to the State Council for convention. This report would be submitted at the first of April rather than at the convention.
- 5. I also suggest that for the next two years the qualification to have two admission degrees be removed to give councils a chance to learn the new admission degree.
- 6. The following is the suggested point system which could be implemented if the State Council wishes to go to the point system on our awarding of awards.

## POINT SYSTEM

Each councils project will count for 20 points, additional points from 5 to 10 can be earned upon the amount of additional man hours put forth to do the project.

#### EXAMPLE:

A council makes a donation to the Heart Fund---20 points, but the council used 5 Brothers, collecting on the streets for 8 hours to collect the donation. This is a basis for additional points +10 additional points. If only a check from the treasury would have been needed, no great number of man power would have been needed. So the greater number of points is not justified. Any project taking more than 20 man hours would get +5 points. Any project taking more than 40 man hours would get +10 points. To qualify for the honor and distinguished awards, the following point brake down would be implemented:

Each of the following point brake downs would have to be made.

Report officers 50 points (must be made for honor and distu.) Audits for June and December 50 points (must be made) for honor and distu. Attain a 5% increase in membership (Have to have for distinguished council) mandatory projects for distinguished council.

#### REPORT OF CEREMONIALS COMMITTEE

A verbal report was rendered by the Chairman PSD Hilton Seymour.

#### PRO-LIFE

When our State Deputy Called to ask me if I would accept the chairmanship of the Pro-Life Committee, I hesitated to accept again. My first year as Pro-Life Chairman, I did not know what to do or what needed to be done. As the year progressed, I learned a lot about Pro-Life. I did accept--with the thought that I could do better.

The first thing I did was to watch and listen to the candidates that were running for the Presidency to see who would come out with the best Pro-Life stand. Mr. Reagan was the most forthright of the candidates in saying that he regarded the unborn as human persons, that he favored legal protection of their right to life.

Next, I prepared a fact sheet on how our Senators and Representatives viewed the Human Life Amendment. This research was done so you could see how you wanted to vote in November. I submitted this information to be printed in the October newsletter. However, for some reason, this fact sheet was not printed in our newsletter. Therefore, I quit using the newsletter to print my letters. Instead, after this, I started writing the Pro-Life Chairman of each council.

I asked each Pro-Life Chairman of the councils in the state to ask their priest to use some of the Pro-Life material that was sent to them by the Supreme Council Office in the homily on Sunday, October 5 (Respect Life Sunday).

The next order was the let you know that it was the time for a Human Life Amendment. This kickoff was set to go along with the March on Washington on January 22, 1981, and I asked that you write to your Congressional Delegation in support of the amendment.

Then, in November and December, the local paper in Yazoo City started to print an ad for therapeutic abortions that you could obtain in Jackson. I began to work to see if I could get these ads out of the paper. But this is not as easy as you might think. Since someone paid for the ads, under law, the paper was required to print them. So, our only alternative was to run an advertisement next to their aid showing that there was something else a person could do rather than have an abortion. Since I did not have any money at my disposal, my council appropriated \$300.00 to run our ad. However, just as suddenly as the ads were started, they stopped; and, the illustration we had worked up to counteract the abortion ad was never printed.

Perhaps this matter needs to be looked into in other areas of the state in order to determine if this problem exists in other cities.

As the year went on, it was decided by the Pro-Life Committees around the country that now was the time to try and get a Human Life Bill passed in Congress. This Bill would only take a simple majority vote to get passed.

These few programs were not many in number, but very important ones.

At this time, I would like to suggest that future State Chairman need to be instructed as to what is expected of them and what means are at their disposal in the way of money, materials, etc. in order to continue the important work in Pro-Life matters.

It has been my pleasure to serve as the State Pro-Life Chairman for the past two years.

Mississippi was picked as one of the eight councils to participate in a pilot program for vocations to encourage local councils to sponsor candidates for the priestly or religious life, by contributing from council funds \$500.00 or more in the course of the fraternal year to any seminarian or aspirant to religious life, for such things as payment of tuition, board, clothing, books travel expenses, etc. and the council would be refunded \$100.00 by the Supreme Council for each \$500.00 spent. Also each candidate was also to be given moral support along with the financial aid. To date none of the councils have reported any information on this project.

# "THE BISHOP GEROW MEMORIAL FUND" 1980-1981

I am happy to announce that we have exceeded last year's total by \$2,720. This brings our grand total since the fund was started in 1953 to approximately \$235,433.

In 1953 we started this program with a donation of \$125 from the four Coast Councils-- Bay St. Louis, Gulfport, Biloxi, and Pascagoula and now we are receiving contributions from most of our 27 Councils and Squire Circles, and Ladies Auxiliary Units.

I am sure that most of you know that the Council's contribution is given to the Bishop of the Diocese in which the Council is located. In 1981, we gave Bishop Joseph B. Brunini, Bishop of Jackson a total of \$6,670 and to Bishop Joseph L. Howze, Bishop of Biloxi a total of \$15,971.

I want to take this opportunity to mention a few outstanding Councils: Pascagoula Council donated \$8,865 (\$100 was raised by the Ladies Auxiliary; Long Beach Council donated \$900 but in addition contributed \$1,100 to the Vincentian Fathers who staff

their parish Church; the Seneca Council donated \$2,300 and it is one of the smallest Councils (40-42 members). These are just highlights.

I wish to thank all of the Councils that have participated in this program and the sacrifices that they have made in time, money, and effort...I do appreciate your cooperation. I also wish to thank State Deputy Rodney Sandoz for the honor and privilege of serving as State Chairman.

## REPORT OF THE FOURTH DEGREE District of Mississippi

To: 77th Annual Convention of the Mississippi State Council Knights of Columbus, Meridian, Mississippi

Former Master George Fero conducted a successful exemplification of the Fourth Degree in Long Beach, Mississippi on May 18, 1980 utilizing the Degree Team from the Msgr. P. J. Carey Assembly Pascagoula.

In September 1980 I was informed by the Supreme Master that I had been selected to relieve Master Fero as Master of the Fourth Degree, District of Mississippi. Those of you who were in attendance at the District Meeting as delegates or visiting Sir Knights in April 1980 know that Master Fero at that time did not desire for his name

to be submitted for renomination. I am quite confident had Master Fero's name been submitted for renomination the Supreme Master would have seen fit to reappoint George Fero for another term as Master District of Mississippi Fourth Degree Knights of Columbus.

Before proceeding with this report, I would be remiss, if I did not state that the District of Mississippi Fourth Degree Knights of Columbus prospered and grew under the able guidance of Former Master Fero. The transfer of the mantle of responsibility was effected smoothly and most efficiently without disruption because of the complete and up-to-date set of records and files maintained by Former Master Fero. Again my thanks to Former Master Fero.

To continue my report, as Master of the District of Mississippi I intend to carry out the duties of the Master's office to the best of my ability and in the best interest of the Order during my tenure of office.

The Religious Education Fund remains in affect as in previous years and at the present time the Fourth Degree is sponsoring the religious education of a Brother and a Sister in the Near East through the Catholic Near East Welfare Association.

Since assuming the office of Master I have visited six assemblies in the District as well as attending three Admission Degrees, one Formation and Knighthood Degree, and the Provincial Meeting held in Gretna, Louisiana.

One of the problems confronting any organization is membership, the Fourth Degree is not immune to this problem. Without the continuing interest and concern of the membership of an organization to increase its membership, the organization tends to become stagnated. With stagnation comes loss of productivity, loss of interest, apathy and worst of all downfall.

However, as the Knights of Columbus in the Mississippi Jurisdiction continues to grow and flourish under the capable leadership of the State and Local Council Officers, so should the Fourth Degree grow as more and more members of the Third Degree become eligible for membership in the Fourth Degree of this great Order of ours.

Nevertheless, the Fourth Degree will not and can not grow at the equivalent or proportionate rate until it functions as a complete and unified body of dedicated Sir Knights. Complete unification requires each member and each assembly to act as a unit to do their utmost in carrying out to the fullest extent possible those projects and obligations that are assigned or delegated by the Supreme, Provincial, District and Local Officers to which the assemblies belong.

In addition to the foregoing, each member of the Fourth Degree must become a dedicated one-man recruiting force with a goal of attracting new members through percept and example. Only in this manner will you be able to attract the fine Catholic gentlemen that are available and only waiting to be asked. In doing so we should be able to double the membership of the Fourth Degree in the Mississippi District.

I believe that every assembly can and should make a determined effort to set as a goal, a goal that may not be easily attained, but at least a goal that presents a challenge and a starting point to have as a minimum one third of the membership of each council under its jurisdiction to become active members of the Fourth Degree. You must however, remember, that in most cases those Third Degree members that are eligible to become members of our distinguished Order must be approached and asked.

An exemplification of the Fourth Degree is scheduled to be conducted in Pascagoula, Mississippi at the Msgr. P. J. Carey council home on Saturday May 23, 1981. The Vice Supreme Master, John H. Shields, as well as several District Masters of the Bienville Province will be in attendance for the day and evenings activities.

Once again, I would like to take this opportunity to thank Former Master Fero and all the other Former Masters of the Mississippi District and to express my heartfelt appreciation for their capable and most welcome assistance during my first months in office.
