PROCEEDINGS OF THE 79TH ANNUAL STATE CONVENTION MISSISSIPPI STATE COUNCIL KNIGHTS OF COLUMBUS

Friday, April 22, 1983

The 79th Annual State Convention of the Mississippi State Council, Knights of Columbus was convened at 6:00 p.m. with State Deputy Don Oldmixon calling the meeting to order. After the opening prayer and pledge of allegiance to our flag, convention chairman John Cox introduced the Grand Knight of Council #1605, Harry Green who welcomed the convention on behalf of the Pascagoula Council. He then introduced Mayor Roy T. O'Bryant, Jr. who welcomed the Knights of Columbus to the City of Pascagoula.

State Secretary Robert Fratesi responded on behalf of the State Council after which Grand Knight Green turned the gavel over to State Deputy Don Oldmixon who officially called the convention to order.

In the absence of State Warden Michael Leleux, State Deputy Oldmixon appointed Harry Steinwinder to check travel cards and vouch that only qualified Third Degree members were present.

The delegates voted to dispense with the reading of the minutes of the 1982 State Convention on a proper motion and seconded. The minutes were then passed out to all of the delegates in attendance. STATE MEMBERSHIP REPORT

Brother Knights:

Before giving you the facts and figures concerning our membership program, I would like to take just a second to thank our Worthy State Deputy for allowing me to participate again this year in our State Program. I would also like to thank all of you who have worked so very hard this year and for many years to make our fine order the success that it is.

Now for the membership report which will be given in two parts.

We began our State Council year on April 1, 1982 with 31 councils and 3998 members. During the ensuing year we were able to add 3 councils for a total of 34 councils and a net increase of 160 members to bring us to a total of 4158 members.

As you know our State Inter-Council Program requires a 5% increase in membership and 17 of our councils achieved that goal. We also had 11 councils that ended the year with a loss. Two of our councils have failed to add any members this year.

Our Fraternal year began July 1, 1982 and due to our successful new council development program last year we moved into Division IV for the first time. By August 1 we were in first place in our Div. but we have since slipped to 5th.

As of April 1, 1983 we have brought 270 new members into the order but we have lost 138 for a net increase of 132 members. As you can see 138 lost members is a big handicap that we must overcome if we are to achieve the greatness in Mississippi that we have the potential for. It will come by closing the back door through which we are losing members.

Again many thanks to all of you for your many hours of hard work in the name of Columbianism and I am looking forward to working with you to further our goals in the years to come.

STATE PROGRAM DIRECTORS REPORT

As we conclude the 1982-83 State Program Year, it is my pleasure to report the achievement of a successful and rewarding year in Columbianism.

The year began last April at the conclusion of the 1981-82 year. Plans were established to evaluate the previous years program and recommend improvements for the new year. This was accomplished by the results of a State Awards Program Survey and a very successful program committee meeting at the convention. The results of the Survey and the committee's recommendations as reported at last year's convention was used to modify the State Program Activities.

The basic purpose, format and design of the Awards Program Guidelines and Report Form using the Point System was highly recommended again. Major modifications were to expand requirements and clarify definitions and descriptions of each project area. Newsletter and yearbook requirements were modified, also.

A new introduction this year was specific instructions for each council to prepare and enter nominations for the Best Single Activity in each program area; Church, Community, Council, Youth and Family Life.

Immediately upon reappointment for 1982-83, the State Program Committee began to develop this year's program. Our goal was to have the tentative program guidelines and report form available for instruction at the schools of Columbianism. Final modification and approval could not be completed until the State Summer Meeting in July. This delayed final information being distributed to each council until the fifth month of the Program Year.

A council report checklist was sent to all councils and District Deputies prior to the October and April report dates. Sixteen councils reported in October and twenty-one reported by the April 1st. deadline. Last year only seventeen councils reported.

The reports indicate increased program activity as well as a better understanding of how to report. We are especially encouraged by the number of councils who increased their program activities this year. The credit can be given in several areas, but the Schools of Columbianism must be considered as an important factor. With only one exception, all councils who reported, participated in the Columbianism Schools. Surely, the schools must have influenced the officers and chairmen of the participating councils.

The Executive Secretary of the State Council in Louisiana was our guest at the Mid-Year State Meeting. He complimented the quality of the programs we are conducting, specifically the Awards Program. Likewise, he suggested we address several areas for improvement. Hopefully, this can be done at the Convention Program Committee Meeting and details reported for consideration. Further details will be reported in the Program Committee Report.

The past two years as your State Program Director has been very rewarding for me. We carry out the Principles of the Order thru our programs and projects, therefore in this position one quickly learns the real reason for Columbianism.

My sincere appreciation to all who assisted in any way. A very special thank you to State Deputy, Don Oldmixon, for giving me the opportunity to serve.

Presently all councils are gearing up for this year's Mental Retardation Drive to be held the week following the State Convention.

It has been most gratifying to have enjoyed the privilege and opportunity to assist the Councils in District 8 in the practice of Columbianism. The appointment by the Supreme Council on the recommendation of the State Deputy as District Deputy District 8 provided the opportunity to grow in the understanding of the purpose of the Knights of Columbus.

The Councils within the jurisdiction of District 8 are 1244 Biloxi, 1605 Pascagoula, 5654 Ocean Springs, and 7910 Gulfport (Orange Grove).

The year began with attendance at the Organizational Meeting of the State Council at which time District Deputies were installed and the activities for the ensuing year discussed.

The Officers of three Councils were duly installed by the District Deputy at open meetings as were the Officers of Ladies Auxillaries of two of the Councils. The Officers of one of the Council were installed by a Past State Deputy as they insisted on being installed prior to the official appointment of the District Deputy.

Two of the Councils were represented at the School on Columbianism held in Gulfport in July.

The 1st Degree Team of Council 1605 participated in five (5) degree exemplifications with a total of 36 candidates all attended by the District Deputy. The District Deputy also attended one 1st degree explification by the Degree Teams of Councils 1244 and Council 5654 with 3 and 7 candidates respectely. Council 5654 Degree team initiated candidates for Council 1522, Bay St. Louis. Council 7910 does not have a 1st Degree Team. Candidates from Council 7910 are initiated by Council 1583, Gulfport. The four Councils have as of February 28, 1983 a net increase of 49 members for the

Fraternal Year which will end June 30, 1983. Three of the Councils have attained their membership quota. One Council has neither a net increase or a net decrease in membership. Two of the four Councils have also exceeded or equaled the insurance quota. The membership chairman and the insurance representative are to be commended for their good work.

Three visits to business meeting of each of the four Councils were made by the District Deputy during the Fraternal Year. All Councils are diligently working toward high achievement in the promotion of Columbianism. There is no lack of leadership in any of the four Councils. A review of records maintained by the Recorder, the Financial Secretary, and the Treasurer of all four Councils indicates that records are being maintained as required by the Supreme Council.

The District Deputy and Officers of three of the four Councils attended the Mid-winter Conference in Jackson on Sunday, January 12th. A District meeting to discuss activities of the Mid-winter Conference was hosted by Council 5654 on February 4, 1983. All four Councils in the District were represented.

VOCATIONS COMMITTEE REPORT

The State Vocations Committee was extremely active during the past year as the Vocations Program was being implemented. The eight point program formulated by the Vocations Committee was adopted by the State Family at the organizational meeting held in Jackson in July. Activities have been reported in seven of the eight projects outlined in the State Vocations Program.

Vocations Workshops held in Biloxi and Jackson during November were a tremendous success. Thirty four Knights representing 14 Councils attended the seminars. Both Father Charles Venus, Vocations Director for the Biloxi Diocese and Father Chuck Siebenand, Vocations Director for the Jackson Diocese presented excellent workshops. Group discussions during both workshops were most inspirational.

The Diocesan Vocations Directors mailed 652 letters to graduating seniors during the year to stimulate the Vocations Awareness Program. The names of seniors were supplied to the Vocations Directors by the local Councils. Seniors were reminded of the religious vocations as a way of life but that selecting another profession was also considered a vocation and was blessed by God.

Both annual CYO Conventions held in February provided vocations displays and hand out material. Father Chuck Siebenand held a vocations workshop in conjunction with the CYO Convention held in Jackson. Father Thomas of St. Joseph's Seminary touched on vocations activities during his Learning to Pray Workshop conducted in Biloxi. I attended this CYO Convention and was very much impressed with the workshops and the behavior and attitude of our young Catholics.

Both Vocations Directors have completed their vocations slide presentations which are available to all councils upon request. Father Charles Venus presented his slides at the Biloxi Vocations workshop which certainly was a moving experience. Father

Chuck Siebenand provided his slide presentation at the six vocations workshops he and Sister Sharon Sullivan conducted in the Diocese of Jackson during January.

Vocations programs were presented at the Jackson workshop held in August and the Mid-Winter Meeting held in Jackson during December. Programs were also provided for all councils that requested a vocations presentation.

The majority of Councils across the State supported and implemented the Eight Point Vocations Program. Members of the Vocations Committee would like to express their appreciation to the State Deputy, Don Oldmixon, the State Family, Grand Knights, Council Vocations Chairmen for their active participation in the Vocations Program.

I personally want to commend Father Charles Venus and Father Chuck Siebenand for their personal committment and dedication in coordinating the many vocations activities during the past year. Becuase of their diligent efforts, the Vocations Program was a great success.

We have again been successful in our campaign to raise money to help educate future priests for Mississippi. A total of \$30,243.87 was raised for this purpose and divided as follows: Diocese of Jackson \$11,715.27 and the Diocese of Biloxi \$18,528.60. Since this program started in 1953 over \$290,000 has been contributed to this program.

The five newest councils are to be congratulated for their contributions and cooperation: Brookhaven No. 7915; Columbus No. 7974, Pearl No. 8038; McComb No. 8054, and Jackson (St. Therese's) No. 8285.

Two Trophies were awarded for this program again this year.

- 1. The Msgr. P. J. Carey Council No. 1605 of Pascagoula was awarded the trophy for the largest donation of \$7,100.
- 2. Our Lady of Perpetual Help Council No. 7211 of Lumberton (Seneca) had an average of \$77.14 contribution per member, thus receiving a trophy.

For the benefits of those who are not familiar with this program it should be stated that the money remains in the Diocese where it is collected (where the Council is located) and is used by the Bishop of that Diocese.

LIASON OFFICER TO THE LADIES AUXILLIARY REPORT

Worthy State Deputy:

This being the first annual report of the State Knights of Columbus Liason Officer to the State Ladies Auxiliary of the Knights of Columbus it is to be one of observation and opinion and recommendations rather than a report of accomplishments.

As you know the office was created as an aid to and communication with the State President of the State Ladies Auxiliary of the Knights of Columbus, Mrs. Terry Nause. Its purpose was to keep her informed of the desires of the State Council in regard to the State Ladies Auxiliary.

The office has proven as an aid in communication in several areas.

- 1. It has helped to pattern the organization of the auxiliary along the lines of the State Council.
- 2. It has helped to develop the function of the District Regent similar to that of the District Deputy.
- 3. It has suggested the use of the District Regent as installing officer of local Auxiliary Officers in her Region.
- 4. It has served as a link between Councils, that do not have an active affiliated Auxiliary, and the organization of an Auxiliary, by the District Regent.

- 5. It is hoped that it will be a means, in the next year, to develop a new Auxiliary development program.
- 6. It can be the means to encourage the affiliation of all existing ladies groups with the State Auxiliary.
- 7. The need to have a local Council officer or committee as a link between the local Auxiliary and the local Council is evident. This could lead to a more revelant relationship between the State Council and the State Auxiliary.
- 8. It is evident that an intense new auxiliary organizational development effort is needed.
- 9. With 34 Councils in the State and only 6 affiliated auxiliaries in the State Auxiliary, as of the printing of the 1982-1983 State Council directory, a great effort is needed to induce the existing ladies organizations to become affiliated with the State Auxiliary.
- 10. The State Auxiliary is very well set up both state wide and on the district level with district regents in all but two districts.
- 11. It appears that each council must put forth an intense effort to form an auxiliary and insist that it affiliate with the State Auxiliary even to the point of contributing the \$1.00 state dues, per member, from council funds.
- 12. It is recommended that the Liason Officer be continued as a means to convey the desires of the State Council to the State Auxiliary.
- 13. It is also recommended that each council have a liason officer as a link between the local council and local auxiliary or as an organizing leader to take steps to form an auxiliary, if one does not exist.
- 14. It is also recommended that if a local liason officer is appointed that he coordinate his efforts with the District Regent, in his District, if there is a District Regent.
- 15. The first year has had limited success but none the less it has been successful and in the future can lead to the desired communication between the State Council and the State Auziliary as was the original intent.

I wish to thank State Deputy Don Oldmixon for the appointment as first State Liason Officer and hope I have met his expectations. To the new incoming State Deputy I wish to state that I will continue in this capacity if he sees fit to reappoint me.

My sincere thanks to State Auxiliary President Mrs. Terry Nause.

MENTAL RETARDATION PROGRAM REPORT

The Knights of Columbus in Mississippi have had another successful Tootsie Roll Drive for the Mentally Retarded in Mississippi. This money will be distributed to over 75,000 mentally retarded persons in Mississippi. We will send everyone a final distribution report when we receive all of the data from the Councils.

We want to thank each and every brother Knight, their families, and friends of the Knights of Columbus, and the Mississippi Association for Retarded Citizens, for all of their hard work in helping others who cannot help themselves. We set a goal of \$65,000.00 in 1982. We did not achieve this goal, but with your enthusiasm and devotion to this project, we collected a net income of \$60,460.51.

The Mississippi State Council will again act as the Board of Directors of the Knights of Columbus Foundation of Mississippi. I have asked the District Deputies to act as District Chairmen for the 1983 program.

The District Deputies will present this program to the Grand Knights at their District Meeting in March or April. The Grand Knights are asked to present the program to the membership at a council meeting prior to the Drive.

The Grand Knights should have appointed a Local Council Chairman and sent his name and address to me. We ask your serious consideration in selecting a Local Chairman, and give him your full support and aid in selecting his Committee Chairman.

We have set a Net Income Goal of \$70,000.00 for the State of Mississippi in 1983. We should achieve this goal if we maintain our enthusiasm in this program. We hope that each and every one of you will visit your local Mentally Retarded Association and see how your contribution has helped that organization. If you need any stimulation in this program, that visit will be all that you will need. Not every Council participated last year. We hope that every Council will participate this year.

The State Deputy presents a trophy to the Council that collects the largest net income per member. The Philadelphia Council won the 1982 trophy with a net income per member of \$105.89. The State Deputy will present the highest gross income per Council Trophy to the Jackson Council. They collected a gross income of \$7,345.42. We all want to congratulate both of these fine Councils for their extraordinary work for the Mentally Retarded in Mississippi.

The proceeds of this drive will be sent to us and we will deposit your proceeds in an account for the Knights of Columbus Foundation of Mississippi. The co-signers of

this account will be the State Deputy and the State Directors. When you send your Council Disbursement Fund Request Form to us with your Federal Tax Exempt letter, we will return your funds immediately. Remember, ALL funds must be disbursed prior to June 30, 1983.

This year we ask you to use the week of May 2nd through May 8th to collect for this drive. The first part of the work is for business donations and Friday the 6th and Saturday the 7th for city-wide drive. Our insurance for workers collecting for this drive will only be in effect on Friday. May 6th, and Saturday, May 7th.

Twenty-five percent (25%) of the net will be for the State Council Retarded Program and seventy-five percent (75%) of the net for local council retarded programs. The money raised must be spent to aid in the area of mental retardation and only that area.

Remember, with every two cases of Tootsie Rolls you receive one cap and one cannister bank free. Additional caps and cannisters may be ordered at a nominal cost, but don't wait until the last minute. If aprons are needed they can be ordered from N. Henry and Sons, Inc., 1644 N. Honore Street, Chicago, IL, 60622. The cost of the aprons are \$3.50 each, plus \$1.50 handling charge per order -- and postage -- (United Parcel Service.) Direct your correspondence to the attention of Mr. David von Bergen.

All monies less the cost of Tootsie Rolls and aprons should be forwarded to the State Co-Chairmen immediately on completion of the drive. Billing for Tootsie Rolls and aprons will be to the ordering indvidual (council) and they should be paid for at that level with monies withheld from the total receipts for that purpose only -- no other monies can be expended. Strict control by councils should be exercised in all areas of this program. Tootsie Roll orders of 50 cases or more will be sent freight prepaid -- smaller councils can consolidate their orders through their District Deputy and take advantage of prepaid freight. The District Deputy will order for all councils in his district. The interest on savings paid all of the expenses of the 1981 State Mental Retardation Program.

A program outline, along with a set of guidelines and sample proclamation, are enclosed for your convenience to promote the drive. As soon as the project is completed, send all monies to State Co-Chairmen, Ricky Nause and Dave Atteberry, with report forms as indicated.

A full report will be made to all members in every council as soon as the project is completed.

If you have any questions or difficulties, please contact us. I would appreciate it if you would invite me to your council to help explain this program.

STATE PROGRAM COMMITTEE REPORT

The State Program Committee met at 1:00 p.m. April 23, 1983. This year the State Deputy modified the design and scope of responsibility of the State Program Committee by combining committees previously meeting separately into one. He assigned all State Program Activity Directors, most State Chairmen, specific Delegates, invited State Officers, Grand Knights, and Council Program Chairmen to meet as one unit chaired by the State Program Director. We were to evaluate the 1982-83 State Program and recommend modifications for 1983-84.

Approximately thirty members attended and wish to make the following observations and recommendations:

- 1. Overall structure and objectives of the State Program are in accordance with Supreme recommendations and serve the basic needs of each local council.
- 2. State Awards Program using the point system is a valuable tool to motivate and evaluate local council programs.
- 3. The Awards Program Guidelines and Program Directors Report Form are better understood this year. Only modifications to further clarify and update should be made. Major areas are discussed herein.
- 4. Program Directors Reports due from councils on October 15 and April 1st. were sufficient to report and analyze activity.
- 5. Program presentations in Schools of Columbianism should be modified to provide "hands on training and examples" in a workshop atmosphere.
- Special efforts be made to insure that all information presented in all workshops is the same.
- 7. State Program Director provide a critique to each council, submitting an October Program Directors Report, advising improvements in program and reporting procedures.
- 8. Provide list of audited point totals for the April 1st. Program Directors Report.
- 9. State officers and Chairmen should insure that, all young councils and others needing help, get any assistance needed and assist the District Deputy to provide it.
- 10. Provide additional explanation and training on how to calculate and record bonus points on the Program Directors Report. Projects that require extra manhours should continue to have extra point value.

- 11. Newsletter and Yearbook Guidelines be continued with explanation and examples given in training workshops.
- 12. The use of Form SP2-nc for Supreme Program Awards for Best Single Activity worked well and should be continued with further explanation of preparation requirements.
- 13. Provide expanded guidelines for preparing Grand Knight, District Deputy, State Chairmen and State Officer Reports for preparation of a booklet for distribution to Officers, Delegates, etc. at the convention.
- 14. Explore possibility of modifing the formats of the Grand Knights and Program Directors Reports so that the same information could be copied (example-optional program projects) and not be written separately for each report. Caution: Major changes in format maybe to confusing.
- 15. Recommend that the State Program Committee meeting at the State Convention thru its critique of the previous year and its recommendations be the basic guideline for the next program year with the opportunity for minor changes to be made by the succeeding State Program Committee. Local councils need basic guidelines between April and July to plan its programs during the first months of the Program Year.
- 16. Modifying the Convention Agenda for expanded committee meeting time worked well. The involvement of all State Activity Chairmen, Grand Knights, Program Chairmen and etc. in one program meeting should be continued again next year.

NEW COUNCIL DEVELOPMENT REPORT

Our 1982-83 New Council Development efforts began at the State Summer Meeting as the District Deputies were given the primary responsibility. They were to be assisted by a key contact person assigned per location and the insurance representative. The State Chairman would serve as the coordinating contact for each District Deputy. Prime locations were selected in each District and development kits were ordered from Supreme. A goal of six new councils was considered reasonable.

Thus far, efforts have netted one chartered council, St. Theresa in Jackson and two locations, Holly Springs and Corinth-Bonneville, which are about fifty percent complete. Other areas are scheduled for development activity prior to July 1983.

Our success this year is much less than last year when six new councils were added. What caused the difference? What should our recommended strategy be for next year? The following questions and statements are offered for consideration by next years Officers, District Deputies, Chairmen and committees.

- 1. Bylaws give the District Deputy the administrative responsibility for developing new councils. What other assistance should he have during the organization period?
- 2. Should there be a New Council Development Committee on the State Level?

- 3. Who should be responsible for development strategy at the State Level?
- 4. What critera should be used to determine potential locations?
- 5. Some large councils have several large parishes in area. Should additional councils be developed?
- 6. Should consideration be given to small parishes with less than 100 family units?

The New Council Development Committee at last years convention recommended we strive to have a council in every parish. Also, they suggested credit be given thru the State Awards Program to existing councils who assist in establishing new councils.

The future development of the Order in Mississippi is the Question. How it is to be accomplished has yet to be determined.

REPORT OF THE 4TH DEGREE

To: 79th Annual Convention of the Mississippi State Council Knights of Columbus, Pascagoula, Mississippi

In October 1982, I was informed by the Supreme Master that I had been selected to relieve Master George Fero as Master of the Fourth Degree, District of Mississippi.

I wish to express my sincere thanks to Former Master Fero for his invaluable assistance during my first few months in office.

In the interest of maintaining a closer working relationship with the assemblies the District has been divided into four areas with a Marshal in each area. Appointed to serve as Marshals in their respective areas were: Area One; which covers Pascagoula, Biloxi, Gulfport and Long Beach; Sir Knight Bernarde Frederick of Pascagoula; Area Two: Laurel, Hattiesburg, and Natchez: Sir Knight Charles Lombardo of Hattiesburg; Area Three; Meridian, Jackson, and Vicksburg; Sir Knight William Karn; Area Four; Clarksdale, Greenwood, Cleveland, and Greenville; Sir Knight William LaForge of Cleveland. These Sir Knights, along with other duties, will assist the District Marshal, Norman McDonald, when in their area.

A meeting was held in Jackson for ARea Three on January 15. The assemblies participating felt that this was a step in the right direction. A meeting for Area Two was scheduled in Hattiesburg for February 13 however due to my sudden and unexpected incapacitation, the meeting was canceled. More meetings will be scheduled throughout the District.

Since the convention last year there have been two Exemplifications of the Fourth Degree in the District. Former Master Fero conducted an Exemplification on August 29, 1982, hosted by Msgr. P. J. All necessary requirements and except for a minor detail will soon be forwarded to Supreme for comformation.

The Religious Education Fund remains in affect as in previous years and at the present time the Fourth Degree is sponsoring the religious education of a Brother and a Sister in the Near East through the Catholic Near East Welfare Association.

Since assuming the office of Master I have visited four assemblies in the District as well as attending three Admission Degrees, the Provencial Meeting in Memphis, Tennessee, and the Installation of the Master of Louisiana District One, in New Orleans.

The Fourth Degree Honor Guard has been active in many areas of the District at wakes, funerals, Corporate Communions, and Confirmations.

Membership is the basic requirement of any viable organization. Without new members no organization can long survive. However, membership is not the only facet of the spectrum. In order to create interest in our Order we must have an active program. A program with enough charisma to keep the members we now have and to make others want to join our ranks. These are the areas in which we will devote our energies and talents.

RESOLUTIONS COMMITTEE REPORT

RESOLUTION NUMBER 1

This resolution was presented by a committee established by the State Deputy in order to update our State By-Laws.

BY-LAWS -- MISSISSIPPI STATE COUNCIL

In accordance with State Deputy Donald Oldmixon's appointment of a committee to make a through study of the present by-laws, then draw up a new set of by-laws, the committee met at Biloxi, Mississippi on Sunday, October 31, 1982.

The committee meeting was opened with a prayer by Chairman John P. Myers, PSD, at 1:15 p.m. with committee members Hilton Seymour, PSD; Rodney Sandoz, PSD; Dave Atteberry, PSD; present and committee member Fred Westbrook, PSD absent. Ex-Officio Chairman, State Deputy Donald Oldmixon, was also present. The following are the proposed new by-laws.

BY-LAWS MISSISSIPPI STATE COUNCIL KNIGHTS OF COLUMBUS

ARTICLE I NAME AND JURISDICTION

This organization shall be known as the Mississippi State Council, Knights of Columbus, and its jurisdiction shall be co-extensive with the boundaries of the State of Mississippi.

ARTICLE II LEGISLATIVE POWERS

The State Council shall have power to enact and enforce all laws necessary and proper for its government and for the government of its subordinate councils, but no such laws shall be valid if the same shall be in conflict with the Constitution and Laws of the Order.

ARTICLE III MEETINGS OF THE STATE COUNCIL

Section 1: The Mississippi State Council, Knights of Columbus, shall be convened annually between the first day of April to and including the first day of June in each year. The date of said annual meeting shall be determined by the State Deputy. The regular notice of such annual meeting shall be given to each subordinate council by the State Secretary at least thirty (30) days prior to the date fixed thereof.

Section 2: Place of Holding Annual Meetings: The State Council, in Convention assembled shall elect State Officers, delegates and alternates to the Supreme Convention, receive reports of State Officers and Committees, discuss and act upon the affairs of the Order in the State, adopt policies and programs for the good and welfare of the Order and transact such other business and enact such laws, rules and regulations as may be consistent with the Constitution and Laws of the Order.

Section 4: Membership: The officers and members of the State Council shall be those provided for in the Constitution and Laws of the Order. Anyone not a member of the State Council will not have the privilege of the floor, unless by unanimous consent of the State Council meeting.

Section 5: Order of Business: The State Deputy shall call the State Council to order at 6:00 p.m. on the first day of the Convention and the following shall be included in the order of its business:

- 1. Call to order.
- 2. Confirming current membership cards.
- 3. Prayer by the Chaplain.
- 4. Reading of the minutes.
- 5. Announcement of personnel of convention committees.
- 6. Submission of Grand Knights' reports of the activities of their councils.
- 7. Report of committee on credentials.
- 8. Reading of communications.
- 9. Report of State Chaplain.
- 10. Report of State Deputy.
- 11. Report of State Secretary.
- 12. Report of the State Treasurer.13. Report of State Advocate.
- 14. Reports of District Deputies.
- 15. Reprot of committee on resolutions.
- 16. Reports of other committees.
- 17. Election of State Officers, delegates and alternates to Supreme Convention.
- 18. Selection of convention city.
- 19. Unfinished business.
- 20. New business.
- 21. Prayer by the Chaplain.
- 22. Adjournment.

Section 6: Committees: The State Deputy shall appoint the following convention committees:

- 1. On Credentials--to consist of at least 3 members of which the State Secretary shall be a member and chairman.
- 2. On Mileage and Per Diem--to consist of at least 3 members, of which the State Treasurer shall be a member and chairman.
- 3. On Resolutions--to consist of 5 members, which shall include the State Advocate as a member and chairman, and shall include, when practicable, 2 or more Past State Deputies, one of which shall be the immediate Past State Deputy.
- 4. On Audit--to audit the accounts of the State Treasurer, to consist of at least 3 members.
- On State Council Convention--to consist of members determined by the State Deputy to coordinate the State Convention.
- 6. All other committees of which provisions has been duly and regularly made, or which may be deemed necessary to facilitate the work of the convention.

Section 7: State Deputy to Preside: The State Deputy shall preside at all sessions of the State Council, and shall ex-officio, a member of all committees thereof, and shall perform such other duties as may be required of him by the State Council and the Constitution and Laws of the Order. In his absence, the most immediate Past State Deputy available shall preside in his stead over the meetings of the State Council.

Section 8: All sessions of the State Council shall be conducted in the third section.

Section 9: All State Officers, District Deputies, Grand Knights, and committees shall prepare their reports in typewritten form for submission to the State Secretary.

ARTICLE IV PROCEEDINGS OF STATE COUNCIL

Section 1: State Secretary to Furnish Blanks: The State Secretary shall prepare and furnish to the Grand Knights of each subordinate council on or before the first day of March in each year, credential blanks for the ensuing annual meeting of the State Council.

Section 2: Roll of Convention: The State Secretary shall prepare a roll containing the names of all delegates and alternates from the credential blanks presented to and filed with him, which said roll shall be compiled and delivered to the State Deputy prior to the first session of the State Council, and said roll shall constitute the roll of the State Council until the report of the credentials committee has been submitted and the permanent roll determined by the action of the State Council.

Section 3: Delinquent Assessments: Subordinate Councils failing to pay any assessments levied by the State Council or Supreme Council, shall not be entitled to representation in the State Council until all such arrears are paid.

Section 4: The roll shall not be called to vote on any question other than an election, except upon the request of at least 1/3 of the delegates eligible to vote at the session, expressed by standing vote.

Section 5: Expenses of Delegates: The expenses of the State Officers, delegates, District Deputies, and Past State Deputies to the State Council meeting shall be determined by resolution at each State Council meeting for the ensuing annual meeting. Mileage figures, if applicable, will be based on figures furnished by the Mississippi State Highway Department.

ARTICLE V POWERS AND DUTIES OF STATE OFFICERS

Section 1: State Deputy: The State Deputy shall preside at all sessions of the State Council and shall appoint all of its committees. except as otherwise herein provided. He shall be the chief executive of the Order in the State and possess all the powers and perform all the duties prescribed by the laws and rules of the Order and by these by-laws. He shall countersign all checks drawn against the funds of the State Council, in the hands of the State Treasurer, and none of the moneys or funds of the State Council shall be otherwise disbursed. He shall have power to call meetings of State Officers and all Committees provided for the State Council, the expense thereof to be charged to the State Council on presentations of itemized statements, as in these by-laws provided, and he shall be ex-officio a member of all committees of the State Council.

Section 2: State Secretary: The State Secretary shall keep a true and faithful record of the proceedings of the State Council. He shall issue a notice of all assessments levied by the State Council and do all things necessary and proper to secure due payment thereof to the State Treasurer. He shall report in writing at the annual meeting of the State Council, and shall preform such other and different duties as the State Council or the State Deputy may from time to time lawfully assign him, and shall furnish the Committee on Resolutions with such information as may be required by it pertaining to the laws and affairs of the State Council, as the same may be of record in his office. The State Secretary shall prepare a complete printed report of the proceedings of the annual meeting of the State Council, and a copy of said report shall be furnished to each State Officer, District Deputy, Committee Chairmen and Grand Knights of the Mississippi Jurisdiction on or about the following July 1st.

Section 3: State Treasurer: The State Treasurer shall receive all moneys of the State Council and promptly deposit the same in the name of the Mississippi State Council, Knights of Columbus, in a depository designated by the State Officers, or a majority of them, and will promptly issue checks, countersigned by the State Deputy, in payment of accounts approved by the State Deputy.

Section 4: State Advocate: The State Advocate shall be the legal advisor to the State Council on all matters involving questions of the law. It shall be the duty of the State Advocate, upon request, to advise the State Officers on all matters pertaining to the constitution and laws of the Order, and upon the constitutionality of any proposed law or resolution of the State Council.

Section 5: State Chaplain: The State Chaplain shall conduct all religious exercises of the State Council and shall advise the State Council and the officers thereof on matters of religion and Catholic practice, and proposed resolutions or laws of the State Council involving such matters shall be referred to him by the Resolutions Committee for his advice and counsel before same shall be referred to the convention. He shall make an annual report in writing to the State Council.

Section 6: State Warden: The State warden shall act as warden of the State Council at all of its meetings and perform such further duties as may be lawfully required of him by the State Deputy and the State Council.

ARTICLE VI STATE COUNCIL FINANCES

Section 1: Manner of Payment: All checks, drafts, money orders, or other commercial paper or obligations of any kind or character owing to the State Council shall be made payable to the Mississippi State Council, Knights of Columbus, and all withdrawals, of its funds from the authorized depository shall be in the name of Mississippi State Council, Knights of Columbus, by written check signed by the State Treasurer and countersigned by the State Deputy.

Section 2: Levying of Assessments: The per capita assessment by the State Council shall operate upon the membership as of January 1st and July 1st of each year. On the January 1st assessment the Councils shall be billed by the following February 1st and on the July 1st assessment the Councils will be billed by the following August 1st and said assessments shall be based upon the membership figures furnished by the Supreme Council as of record on January 1st and July 1st of each year and shall be due and payable by February 28 and August 31. All other assessments levied by the State Council shall be due and payable sixty days after the date of levy, unless otherwise duly provided.

Section 3: State Council Expenses: The State Treasurer is authorized to pay out of the general fund of the State Council all sums necessary to pay the appropriations authorized and made by the State Council, the expenses of the State Council Meeting, the authorized expenses of officers and committees, and all other expenses duly authorized by the State Officers, but no such payment shall be made of any item of expense unless and until a properly itemized statement thereof shall be filed with the State Deputy.

Section 4: Per Capita Tax: The per capita tax of the Mississippi State Council shall be \$4.00 per member per year, in accordance with Section 118, paragraphs C & D of the Supreme Council By-Laws, provided, however, the per capita tax may be changed by 2/3 vote of the State Council meeting or as otherwise provided in these by-laws.

ARTICLE VII ELECTIONS

Section 1: Rules: The election of the State Officers and delegates and alternates to the Supreme Convention shall be held in a manner to comply in all respects with the constitution and laws of the Order.

Section 2: Nominations: All nominations of officers, delegates, and alternates shall be made from the floor. No nominating speech shall exceed 5 minutes unless a different rule be established by majority vote of the meeting. Second shall be limited to stating their name and council.

Section 3: Tellers: Three tellers shall be appointed by the presiding officer to assist with the balloting. The counting of ballots shall be open to all duly qualified third degree members of the Mississippi Jurisdiction.

Section 4: Unanimous Ballot: When only one candidate is nominated for any office, the State Council, upon proper motion. direct the State Secretary to cast a unanimous ballot for such candidate, without balloting.

Section 5: Order of Election: The order of election shall be as follows. State Deputy--State Secretary--State Treasurer--State Advocate--State Warden--Delegates to the Supreme Convention--Alternates to said delegates.

Section 6: Manner of Conducting: When the nominations shall have been closed for each state office, the names of the candidates for that office shall be written in large letters on the blackboard so as to be plainly legible to all delegates, and plain sheets of paper shall be distributed to each delegate with instructions to write thereon just one name, the choice of that delegate for that particular office. When the nominations for delegates to the Supreme Convention shall have been closed, the names of all those so nominated shall be plainly written on the blackboard, and the delegates shall write on their ballot the exact number of names for the position to be filled, and shall cast the same in one ballot. The same procedure shall be followed in the election of alternates, who shall be designated in the order of their preference, according to the vote electing them, provided that only insurance alternates shall fill vacancies for insurance representatives. In case of a tie vote, the State Deputy shall designate which one shall serve. In the selection of the convention city, the names of the cities that have invited the convention shall be written on the blackboard, and each delegate shall write on his plain ballot the name of one of these cities as his choice.

Section 7: Balloting: Where a contest exists for any position to be filled, the voting shall, in all cases be done by secret, written ballot. The balloting shall be done in the following manner. The State Secretary shall call, from the permanent roll of the State Council Meeting, the names of those persons entitled to vote and as each name is called, such member will deposit his ballot in the receptacle provided therefor.

Section 8: Majority: In all cases of election to any State Office, a majority of all votes case be necessary to elect. In the event there are more than two candidates for a single office, and a ballot fails to produce a majority for any candidate, written balloting shall continue with the candidate receiving the smallest vote on the preceding ballot being dropped from the following ballot until a candidate shall have received a majority of all votes cast.

Section 9: Who Shall Nominate: Any member entitled to the floor at the State Council Meeting may nominate a candidate for any office to be filled.

ARTICLE VIII EMERGENCY PROVISION IN THE EVENT THE STATE COUNCIL MEETING CANNOT BE HELD

In the event, by reason of law, government edict, war, or other proper cause, no annual meeting of the State Council is held in any year or succession of years, the following regulations shall apply to the functioning of the State Council until the next State Council Meeting shall be held:

Section 1: All State Officers shall continue in office as if reelected until their successors have been duly elected and qualified. Vacancies arising in State Offices shall be filled by a majority vote of the State Officers in meeting assembled, the person so elected to hold office for the balance of the term of the office he succeeds, and until his successor is elected and qualified.

Section 2: The state per capita tax set at the last State Meeting shall remain in effect until the next State Meeting is held, except as hereinafter provided.

Section 3: All annual appropriations provided for at the last State Meeting shall be deemed renewed from year to year, except as hereinafter provided.

Section 4: All resolutions of the last State Meeting directing the carrying on of any activity, or vesting an authority in a particular person or committee, shall be deemed renewed from year to year, except as hereinafter provided.

Section 5: To provide for conditions not anticipated at the last previous Annual Meeting, the State Officers are vested with the following powers affecting the foregoing provisions:

- a. They may adjust the state per capita tax from year to year, but may not exceed the tax set at the last Annual Meeting.
- b. They may reduce or eliminate the appropriations made for any committee or purpose, in accordance with changing conditions.
- c. They may create new committees needed to meet a need not anticipated at the last Annual Meeting.

Section 6: State Officers and Committee Chairmen shall continue to make their annual reports in writing, which shall be printed and a copy sent to each Council about July 1 of each year.

ARTICLE IX

Section 1: In the event authorization is needed to carry on the functions of the State Council which goes beyond the authority herein vested, the State Deputy shall submit a resolution covering the authority needed to all the Councils in the state. The adoption of such resolution by a majority of the Councils in the state shall have the same force and effect as if said resolution was adopted at a meeting of the State Council.

ARTICLE X AMENDMENTS AND RULES OF ORDER

Section 1: Amendments: These by-laws or any part thereof, may be amended or repealed at any regular meeting of the State Council by a two-thirds vote of the persons qualified to vote at said meeting. Provided, however, that where notice of a proposed amendment to these by-laws shall have been given, by mail, to the Grand Knight of each subordinate council in the Mississippi Jurisdiction, at least 60 days prior to the date set for the opening of the Annual Meeting, the amendment covered by such notice may be adopted by a majority vote of the members qualified to vote at such meeting.

Section 2: Void By-Laws: Severability: Any by-law, or portion thereof officially determined to be in conflict with the constitution and laws of our Order, shall be forthwith null and void. All provisions hereof not effected by such determination shall remain in full force and effect.

Section 3: Suspension of By-Laws: Any of these by-laws may be suspended at any session of the State Council by a two-thirds vote of the members present at the session in which the motion for suspension is made.

Section 4: Majority Vote: A majority of the members of the State Council shall constitute a quorum. Except where otherwise provided in these by-laws or by the constitution and laws of our Order, a majority vote of the members present at any Annual Meeting of the State Council shall prevail on any questions.

Section 5: Robert's Rules of Order: Except as otherwise provided herein and in the absence of a standing rule, Robert's Rules of Order shall govern the proceedings of the State Council.

Section 6: All previous by-laws and amendments are hereby repealed and revoked as of date of ratification of these by-laws by the State Council Meeting.

The committee meeting adjourned at 3:30 p.m.

RESOLUTION NUMBER 2

WHEREAS, The cost of living continues to rise to a steady increase causing a fiscal problem to the State Council not only in day to day operations and services, and

WHEREAS, projected expenses of this years State Convention are expected to use seventy-five percent of the total annual per capita income, and

WHEREAS, there appears to be no easing of this inflationary increase in sight, and

WHEREAS, if we expect to continue services to our local councils and membership in the next few fraternal years, and

WHEREAS, Article X, Section 1, provides for amendment of State Council By-Laws, therefore,

BE IT RESOLVED that Article VI, Section 4, be amended to read as follows:

Per Capita Tax: The percapita tax of the Mississippi State Council shall be six dollars (\$6.00) per member per year, payable one half (½) on August 1st each year bases on the membership figures of July 1st, and the other one-half (½) payable on February 1st each year based on the membership figures of January 1st, in accordance with Section 118, paragraph C & D of the Supreme Council By-Laws, provided however, the per capita tax may be changed by two-thirds (2/3) vote of the State Council meeting or as otherwise provided in these by-laws.

Now therefore be it resolved, that the sincere thanks of those in attendance at this convention be extended to the host council for the superior manner in which they have discharged their responsibility.

WHEREAS, members from throughout the jurisdiction participated in the tournament in

WHEREAS, it is the express desire by vote of participants to again hold this activity in 1984.

Now therefore by it resolved, that the Mississippi State Council sponsor at no expense itself, the Official Mississippi Knights of Columbus 21st Annual Handicapped Bowling Congress. Time and dates to be set at the discretion of the host council, which is the Natchez Council.

Be it further resolved, that the Mississippi State Council present appropriate trophies at no expense to itself and as provided by the Bowling Association, to the winners of certain events conducted in the tournament.

RECOMMENDATION: Adoption.

RESOLUTION NO. 7

WHEREAS, the members of the Mississippi Knights of Columbus desire to participate in a softball tournament.

Now therefore be it resolved, that the Mississippi State Council Sponsor, at no expense to itself, the Official Mississippi State Knights of Columbus Annual Softball Tournament for its membership said tournament to carry the official sanction of the American Softball Association and Delegating Council 1034 of Natchez as Host Council. Time and date to be set at their discretion and

Be it further resolved, that the Mississippi State Council present appropriate trophies, at no expense to itself, and as provided by the Softball Association, to the winners of certain events conducted in the softball tournament.

An amendment was submitted to this resolution.

The tournament shall begin on a rotation basis in the year 1984 in the northern section. The section of the state hosting the tournament will select which team will

WHEREAS, local council expenses are increasing proportionally with the inflated economy, and

WHEREAS, the payment of delegates for attendance at State Convention comes from per capita assessments with larger councils paying more without additional representation, and

WHEREAS, a whole committee, that of determining mileage and per diema, could be eliminated, and,

WHEREAS, a permanent solution is needed for this inequitable situation,

THEREFORE, BE IT RESOLVED, that each local council pay its delegates expenses to the State Convention and that per capita assessments by the State Council be reduced proportionality.

RECOMMENDATION: Rejection.

RESOLUTION NO. 10

BISHOP GUNN COUNCIL 1583

Be it resolved that the State Convention be a State Council Function to be held at Biloxi and Jackson on alternate years. With the cost of convention be shared by all Councils on a per capita bases.

RESOLUTION NO. 11

WHEREAS, all state jurisdictions going to the Supreme Convention are allocated delegates in accordance to their total membership, and,

WHEREAS, all councils of this jurisdiction are allocated two voting delegates each to the State Convention, in accordance with Chapter II, Section 11 and 12 of the charter, Constitution and Laws of the Knights of Columbus, and,

WHEREAS, the small councils by virture of being allocated two voting delegates have the same voting rights as does the larger councils, and,

WHEREAS, the allocation of two voting delegates, regardless of size of the council, is contrary to the allocation of voting delegates to the Supreme Council, and,

WHEREAS, per Capita Tax, both the Supreme Council and State Council is levied on each council based on total memberships in the council, and,

WHEREAS, the larger councils of this jurisdiction pay the major share of the revenue of the State Council, due to their large membership, and,

WHEREAS, since the voice in developing the policies and purposes of the State Council as well as the assessment of per capita tax has no relationship to the membership of the council, and,

WHEREAS, the small council is deprived of any incentive to increase membership in order to gain representation based upon membership, and,

WHEREAS, in order not to increase the cost of State Council meetings, by increasing the member of delegates to permit equitable representations, now,

THEREFORE, BE IT RESOLVED, that Chapter II, Section 11 and 12 of the Charter, Constitution and Laws of the Knights of Columbus be amended by the Supreme Council so that the voting delegation of the State Convention shall consist of two (2) delegates from each council in the province and that the delegation shall cast a total equilavent to one vote for each member of its council as reported by the Supreme Council as of Last day February preceding the date of the State Convention.

RECOMMENDATION: Rejection.

BE IT RESOLVED, that pursuant to Article IV, Section 5, of the Amended By Laws, Mississippi State Council, Knights of Columbus, per diem expenses of the State Officers, Delegates, District Deputies and Past State Deputies, to the State Council meeting for the ensuing year, are hereby fixed and established to be paid at \$30.00 per day for two days, plus mileage at 20 cents per mile, one way, to be based on mileage figures furnished by the Mississippi State Highway Department, Past State Deputies in attendance will be paid the per diem for two days, and no mileage.

REPORT OF THE 1983-1984 STATE CONVENTION

The State Convention Committee which was appointed by the State Deputy after the 1982 Convention has selected Jackson as the site for the 1984 State Convention. The Jackson area councils; #848, #7854, #8038, #8285 have accepted to co-host and to provide the physical support necessary for an excellent and enjoyable convention. The State Convention Committee including the State Deputy will be financially responsible for any profit or loss. Therefore, all actions by the General Convention Committee will be subject to approval of the State Convention Committee.

The State Deputy appointed me as the General Convention Chairman. I was charged with the responsibility to organize the various committies, research and recommend a site, develop a temporary agenda, present a budget and recommend a registration fee to the State Deputy by March 1, 1983. These responsibilities were accomplished.

The State Convention Committee has dedicated the convention in honor of his Excellency Bishop Joseph B. Brunini, who will retire in June 1984.

The HOliday Inn - Downtown in Jackson was selected. There is ample space for all functions to be held under one roof. A block of 275 rooms, available hospitality suites, meeting and banquet facilities have been reserved. Additional rooms are on standby if needed.

The convention dates are April 27-29, 1984. The basic agenda planned by the committies is similar to past conventions.

Pre-registration is a must to provide the best estimates for housing, food and etc. Details for pre-registration and purchase of tickets will be provided later. As each year a ticket package is included in the registration fee. Separate tickets may be purchased for individual events.

Unfortunately, history has not provided us with statistics from previous conventions except the individual experience of some members. This year we have the State Convention Committee to compile and provide the statistics for future years. The information from the 1983 Convention will be used to update the estimated budget for 1984.

The best estimated cost of the items usually included in the registration fee is approximately \$40.00. This is verified by statistics of this convention. The only way it can be done for \$30.00 is to cut quality or the quantity of items included. To avoid this the registration fee must be increased.

We hope to provide you with a very enjoyable convention at the most economical cost. We will do everything in our power to accompolish it.
