September 8, 2002, was indeed a historical day in Vicksburg - and in the Mississippi jurisdiction, for that matter. Present were Supreme Ceremonials Director, Sam D'Ambrocia, two Supreme Directors, Louis Mautino and Jim Murphy, and eight additional representatives from Alberta, Saskatchewan, Illinois, Michigan, Minnesota, Missouri, New Hampshire, and Texas. They observed all three degrees and certified a new central Mississippi degree team. This was the first new team certified in ten years and the first to be certified by regional ceremonial directors, who were trained while observing the Vicksburg degree work. Mississippi was commended on the quality of its ceremonials. For the new Knights and members observing the degrees, this was a truly enlightening day. State Secretary Rich Lieding coordinated team formation, and State Program Director David Scott is team captain.




## EXEMPLIFICATION SCHEDULE
