## A WORD FROM OUR STATE DEPUTY

Worthy State Officers, District Deputies, Grand Knights, and fellow Knights of the Mississippi Jurisdiction:

We are now 6 months into the State's Fraternal year and a little more than 2 and a half months into Supreme's Fraternal year. I have had a chance to step back a moment and assess the progress of the State's performance thus far. From the State's perspective and what has been accomplished since the convention, I think we could have done a better job. We are still looking for some council forms that have not been submitted, such as the Election of Council Officers (Form 185) and Appointment of Council Service Program Personnel (Form 365) and various council and chairmanship reports needed to complete the Convention Minute book. I am guilty too; I haven't sent the State Secretary my report, but I can assure you that as soon as I finish this article I will finish that project and submit it to Danny Lechner.

We are not yet at 100% on providing information to support the State Directory. FS Mike Kassouf of Starkville has been working diligently to make the Directory on Line work; he has spent numerous hours tracking down information, pleading with Grand Knights and District Deputies to provide the information. What is the impact you ask?

We do not have a complete directory for one which means we do not have a complete mailing list for Grand Knights, which means it is harder to communicate to everyone, which means we have a broken link in our communications chain.

I am glad to report some things are going well. We all sensed a uplifting spirit at the convention and it seems to have been carried over into the new fraternal year's activities. We had a banner new member recruitment month in July and in August. However, as usual our gains were reduced by a large number of suspensions. We gain about 40 new members and dropped 20.

Speaking about membership recruitment, everyone should be planning for and executing activities for the October BLITZ. District Deputies are reminded to submit their weekly reports on to me beginning 10 Oct, then 18 Oct, and 25 Oct. I will in turn send them to our Regional Program Coordinator. Our final report must be submitted by 30 Oct, so it can be furnished to the Supreme Knight by 1 Nov. I ask each District Deputy to take this task on and push their councils to get involved in the BLITZ. Let's make this BLITZ successful as I know we can if we set our minds to it.

We have many activities scheduled for the coming weeks – a Fourth Degree in Hattiesburg on Saturday, September 23; a 2nd and 3rd Degree in

Brandon on Sunday, October 22. Let's not forget about the Biloxi Diocese Respect Life-Life Chain, on Sunday, October 1st. Other activities are included in this issue.

I will be traveling to Birmingham, AL, October 21-22, to attend the Bienville Provincial Fourth Degree Meeting with our Master, Dr. Paul Gospodarski. In November, I will be traveling to Atlanta to attend Supreme's Mid-year meeting, Nov 17-19. Soon I will be scheduling our regional mid-year meetings. If any council in the central and northern region would like to host the meeting in their area, please coordinate it with your District Deputy and then let me know.

District Deputies: I ask your immediate assistance to contact your councils and remind them they must either return their First Degree books to Supreme or write and submit a memo to Supreme telling them the books were lost. In addition, please make sure all of your First Degree Teams have been certified under the new version of the First Degree.

Grand Knights: We need your help on this project too. Please ensure your council's information has been entered into the Directory on Line. One more thing—have you planned a recruitment drive in support of the October BLITZ? What are you waiting for? Show us what you can do, recruit a new member today.

I hear the Priest Education Fund Raffle is going well in some parts of the State, while in other areas need a little push. Deacon Larry Campbell tells me Grand Knight Manfred Carr of Natchez has sold \$1500 worth of tickets and he plans on selling the most in the State. That is quite an accomplishment. How many have you sold?

In closing, let me thank everyone for what they have done to make our Jurisdiction a success. Each time I hear of a success story, it warms my heart and reminds me how great the Knights of Columbus organization is today. Keep up the great work.

Since that awesome and frightening day, we have all witnessed and experienced the overwhelming generosity of so many individuals, groups, churches, organizations, corporations, all pulling together to help our neighbors.

This morning, Cathy and I had the privilege of attending a Prayer Breakfast that Governor Haley Barber held for the many faith groups in Mississippi who have been instrumental in helping so many. Many individuals gave wonderful testimony to what our faith means when it comes to helping those whose needs seem overwhelming. As our Bishop, Most Reverend Joseph Latino said at the breakfast, "I went to the coast and saw the damage and destruction and asked myself, were do I start?" He told the assembled guest, what the Catholic Church across the country did to help, how the Catholic Charities of the Jackson Diocese responded in the immediate aftermath of Katrina and now in the long term recovery process. ## COMMENTS FROM OUR 4th DEGREE MASTER

Gentlemen: I received the following from our Vice Supreme Master, Michael Horten. Please share this information with your brother knights. Our commitment to our veterans are reflected in the service we provide through our VAVS program. Thank you to all who serve those who protect us.

All.

Here is a set of facts and figures that give you an idea of the overall "value-add" of the VAVS to our Veterans and our Nation. Please pass this on to your District Masters and encourage them to send it to their VAVS Representatives.

From Ms. Laura Balun, Director VAVS, writing in the VAVS newsletter "Eagle"

"Last year, through the VAVS, volunteers and the organizations they represent, donated more than \$50.4M in gifts and cash donations. Hours that were donated to VA in volunteer services valued at \$234.8M. When those two contributions are added together, more than \$285 M has been donated to assist with service to veterans. It costs VA\$45.5M for VAVS staff training, salaries (plus benefits), travel and volunteer meals an excellent return on investment."

It most certainly is a major return on investment, indeed! Consider also the hours these VAVS volunteers perform, over 13 M hours in 2005 (104 K hours by KofC volunteers), it is the veteran who is the direct and major beneficiary of this good will or as Fr. Holt, Deputy Chief Chaplain and Senior Catholic Priest Chaplain, VA, would put it "Good people doing good things".

I am very proud to be the Order's National VAVS
Representative and our VAVS representatives and
volunteers at the VA Medical Centers should be very proud
of themselves. The Order of the Knights of Columbus
should take great pride in its membership on the Executive
Committee of the VAVS National Advisory Committee.
