A WORD FROM OUR STATE DEPUTY

Worthy State Officers, District Deputies, Grand Knights, and fellow Knights of the Mississippi Jurisdiction:

Our membership recruitment is still going strong and is being supported by several Major Exemplifications held around the State. During the Degree held in D'Iberville on January 28, 2007, we took in 13 new First Degree members and 48 members received their 2nd and 3rd Degrees. This weekend (February 17) there will be a Major Degree in Clinton and next weekend (February 24) we will be in Starkville for another. We have 2 Major Degree scheduled in March, the first in Kiln on 11 March and Oxford on 24 March. Make plans now to recruit new members for your council and have them attend one of these Degrees in your area.

On the down side, I still receive a large number of suspension which as you know virtually wipe out any significant gains we have. It is upsetting to me to receive a large number of Form 1845s from a council where some members are being suspended for not paying their dues for 4 or more years. In these cases, I question the Grand Knight and Financial Secretaries to see if the proper billing and retention requirements have been met. I say, show me the paperwork where the member was contacted by a member of the retention committee; show me the paper trail. It is very suspicious to receive 30 or more suspension notices all dated the same day. If I feel they the suspension process was not accomplished according to Supreme's guidelines, I contact Supreme and advise them to take no action on the Form 1845s

Everyone should be preparing their councils for the 2007 State Convention to be held in Biloxi, April 27-29. Grand Knights and Financial Secretaries should by now sent in their Delegate selection memos to the State Secretary and State Deputy. These memos also ask for any deceased members and/or spouses. Those attending the convention should submit their convention registration slips and money NOW. In addition, I respectfully request each Council, Assembly, and Ladies Auxiliary to seriously consider purchasing an ad for the convention booklet. Money raised in ad sales help defray costs associated with the convention taken on by the host Council. Both registration and ad purchase forms can be found on the home page for Council 1244, which can be accessed through the MS Knights of Columbus webpage.

Every Council has one more big shot to meet their membership goals for the year by participating in the March Membership BLITZ. Do what you must to plan for your membership drives and have sufficient stock of membership literature on hand to provide to prospective members. Encourage your general membership to prepare themselves on how to approach eligible Catholic men to join our Order—do it for those men so that they may experience the rewards of our fraternal benefits society.

Message to District Deputies: We still have many councils that have not submitted their Annual Fraternal Activities Report which was due to Supreme by January 31st. Likewise, there are several that have not submitted their Partnership with Special Olympics Form. Councils should also be working on their Semi-Annual Audit Report that is due to Supreme by February 15th. Encourage Grand Knights to begin collecting information for their State Program Awards report as well as their Best Activity submissions. Make you district a standout at this year's convention.

Grand Knights: The State Council and Supreme depends on YOU to complete the necessary forms and paperwork in a timely manner. Seek support from your Deputy Grand Knight to complete and submit required reports on time. Don't forget the resources you have available to complete this reports—some can be completed on line from Supreme's webpage (www.kofc.org) and you can also download the program awards formats and instructions from the State's webpage at (www.ms-kofc.org). Do your council right and do us a favor by submitting your reports by the required deadline.
