From the State Deputy 'Go and Do Likewise' Challenges Us as Knights By Peter C. Sukanek

This past weekend, I attended the mid-year State Deputies meeting in Baltimore. At the outset of the meeting, the Supreme Advocate, John Marrella, announced that the Court of Appeals in Boston

rejected the challenge to the words and "One nation under God" in the Pledge of Allegiance. (You can read more about this on line, if you have not already, on the KofC website www.kofc.org.)



As in previous cases, the Knights of Columbus was a "defendant intervenor" represented by counsel before the court. "In reciting the Pledge." the court said, "students promise fidelity to our flag and our nation, not to any particular God, faith or church." The primary effect of the New Hampshire law "is not the advancement of religion, but the advancement of patriotism," the court said. (The original lawsuit was brought against the state of New Hampshire.) The decision, as well as the words of the court, is something for which we should all be grateful and proud. The Knights of Columbus was instrumental in putting "under God" in the pledge and in keeping it there.

This victory supports one of the four principles of our Order, patriotism. In addition, as the Supreme Knight pointed out, the decision is especially significant in that it affirms our belief that the State is not supreme, but is accountable to a higher power: our actions are accountable to God. As Catholics, we believe we are commanded to love God and to love our neighbor. The Supreme Council has named this year once again "The Year of the Volunteer" and has continued with the theme of this year's Supreme Convention, "I am my Brother's Keeper." Both themes certainly describe the Knights of Columbus. We are the largest Catholic fraternal organization in the world, donating over \$150 million to charitable causes and giving over 69 million hours of volunteer work in 2009. We are the volunteers who do Christian charitable work.

At our Mass on Saturday morning, we were reminded of the parable of the Good Samaritan. The expert in the law asked, "Who is my neighbor?" which prompted Jesus' story. At the end, when asked by Jesus, "Who was this man's neighbor?" the expert responded, "The one who showed charity." Jesus did not respond, "That's correct" or "You're right." His response was simply, "Go and do likewise." That is Jesus' command not just to this individual, but to all who would follow him.

The Supreme Knight has challenged each of the more than 14,000 Councils throughout the Order to continue and to extend their charitable works in this fraternal year. To demonstrate to all that we live by our principles of charity, unity, fraternity and patriotism, he has asked that each Council sponsor one additional program in each of our six program areas: Church, Community, Council, Family, Pro-Life and Youth. Is that something your Council can do? Can we demonstrate to our communities in tangible ways that "We are our Brothers' Keepers"?

FS Quick tips

New Honorary Per Capita Charge By Mike Kassouf

Financial Secretaries received a letter in October from Supreme Advocate John Marrella announcing the Order's decision at the last convention to adjust the annual payment for Honorary Members.

Formerly, the annual payment was fixed at \$10, which included State and Supreme per capita charges and levies. As amended, the annual payment for Honorary Members will include the Supreme per capita charge of \$3.50, the Catholic Advertisement assessment of \$1 and the amount of the annual State Council per capita charge of \$2.70, which equals \$7.20. This is the amount you should bill each Honorary Member. Honorary Members on disability are exempt from all dues payments.

In Member Billing do the following: Billing Information > Class List under class for Honorary Members enter \$7.20. When you run billing for 2011 in December, this amount will populate those members who are designated as Honorary Members.

2011 Membership Cards - Effective with 2011, the Supreme Secretary has decided that all future Council membership cards will be white paper, and all future Assembly membership cards will be blue paper. For Member Billing, order #4817 for Council white cards and #4818 for Assembly blue cards.


