State Economy Reflected in PID Collections By James Farris, PID Executive Director

The Mississippi economy continues to be in a less-than-desirable condition, and that is reflected in the contributions made to the 2010-11 People with Intellectual Disabilities program. During the past year, some \$50,000 was received from 26 of the 59 Councils in the state.

Councils sent \$38,000 to their local facilities supporting persons with special needs, and the State Board of Directors sent checks totaling \$32,000 to statewide facilities this spring. These expenditures exceeded collections for the year because last year there was some question as to the type of facilities that were eligible under the rules of our type of charitable organization. As a result, that money was distributed this year.

The checking and savings accounts of the fund are healthy with a small reserve. The checking account balance is \$5,669.67 and the savings account balance is \$8,014.89

Insurance has been purchased for the 2011-12 drive for the week of May 22-28. Councils having liability insurance separate from the state are free to choose another date for the drive.

Convention Vocations Report Knights' Can Play a Significant Supportive Role in Vocations Effort By Deacon Lawrence M. Campbell, State Vocations Chair

To say that we have a shortage of priests in the Dioceses of Biloxi and Jackson is quite evident. We have less than 100 men serving in both Dioceses. Five of the 94 names called at the 2011 Memorial Mass for the Deceased were those of priests who passed to their eternal reward since the 2010 State Convention.

Knights who have attended either of our Bishops' Chrism Masses on the Tuesday prior to Easter Sunday, when all the priests of the Diocese gather at the Cathedrals, see a "sea of gray-haired men." We also have an aging clergy. Because of the small number of clergy and the number of aging clergy, we do indeed have a crisis in the state.

What are some possible ways in which we as men, fathers and grandfathers and our families might help with this crisis?

Prayer, including our personal prayer as well as the prayers of our whole family; encourage men, younger and older, family members, friends and others to keep an open mind to God's call to priestly service; learn to accept diversity, both in race and in language. In Mississippi, we have Anglo men, Hispanic men, Asian men, African men, Polish men and those from other nations; show our priests how we love them. Share with them our affection and extend to them our friendship. Often times this means that we must accept the individual differences of each.

With regard to our seminarians, we currently have 18 men studying for the priesthood in Mississippi, nine in each Diocese. Three of the nine in the Diocese of Biloxi will be ordained in 2011. One man in the Diocese of Jackson may be ordained in 2011.

Let's continue to support seminarians through the RSVP Program. Currently each of them receives financial assistance from the Knights of Columbus through RSVP. Let's continue to support seminarians in other financial ways, even if it does not qualify under the guidelines for an RSVP award or rebate. Stay in contact with our seminarians through cards, letters and email, as well as telephone calls and by sending them our local newspapers. Adopt a seminarian. Treat him as you would treat a priest. Write him at his seminary, acknowledging his birthday and various state and national holidays. Send him a care package. Ask him what his personal needs might be. Support the Bishop R. O. Gerow Memorial Fund for the Education of Seminarians. Support our Catholic Foundations through the Insurance Trust Fund in each of our Dioceses.

Please remember that our seminarians are not necessarily young men but are also older men entering seminary training later in life or following another career. Let's all stay in close contact with our Diocesan Vocation Directors: Fr. Dennis Carver in the Diocese of Biloxi and Fr. Anthony Quyet in the Diocese of Jackson.

Knights of Columbus Chaplains Gather in Order's Birthplace By Fr. Al Camp, State Chaplain

Sixty-six chaplains from throughout the Order gathered in New Haven during the first week of March for the first-ever meeting of State Chaplains.

Father John Grace, O.S.A., director of Chaplain Programs and Development, hosted the meeting which attracted chaplains from 58 jurisdictions including bishops from the United States, Canada and Puerto Rico. The meeting was a follow-up to the State Chaplains Pilgrimage to Rome to celebrate the end of the Year of the Priest last June. Having been on the Rome Pilgrimage with the Chaplains, it was a great experience to be with the same chaplains in New Haven.

In his opening remarks, Supreme Knight Carl A. Anderson reminded us that the Knights of Columbus and its leadership are committed to making the Order and its members participants in the great renewal of the Catholic Church today. He also spoke to us about the need for a strong relationship between the clergy and the laity. "We will keep our Church strong through parishbased Councils. These Councils and their members will keep the parishes active and healthy, the laity united with pastors and priests."

Supreme Chaplain Bishop William E. Lori of Bridgeport, CT, gave a very inspirational homily at the opening Mass at St. Mary Church where Fr. McGivney offered Mass so many times. His remarks were based on the Gospel of the day, an account of Jesus making his way to Jerusalem telling his disciples of his passion and death and resurrection and asking his disciples if they were willing to drink the cup. Jesus concludes the Gospel account with the reminder that He did not come to be served, but to serve. This. Bishop Lori said. is also the role of the chaplain and all priests as we continue the work of Fr. McGivney. Bishop Lori concluded: "What an honor it is to offer Mass with you in this parish church where Father McGivney daily offered the Eucharist. We follow in his footsteps as chaplains in the Knights of Columbus."

In another session later in the week, Bishop Lori presented a detailed and informative discussion of the Four Principles of the Order. He concluded by encouraging chaplains to help all Knights and their families grow in the faith and bring that faith to the world.

J. Michael Durbin, Senior Vice President for Membership Growth, told us about the three priests who made a tremendous difference in his life and asked that pastors, chaplains and parishioners support the Knights of Columbus in every way possible.

George Hanna, Senior Vice President for Fraternal Services, reminded us of the need for programs for Church, Community and Society such as the Ultra Sound Program, Coats for Kids, picnics, communions and other activities which are centered on the family.

Rev. Grace outlined the **10 Keys of Success for Chaplains**. He stressed the importance of the Chaplain's report, which, he said, should be called a "reflection" and should be scheduled at the very beginning of the meeting. The chaplain should call attention to the truths found in the *Compendium of the Catechism of the Catholic Church* and the social teachings of the Church. He noted the problem of the 50 percent divorce rate and the radically dropping number of annulments and how that might affect membership. He included a short statement on the new Rite of Initiation for the Third Degree centered on the Eucharist.

Thomas Smith, Jr., Executive Vice President for Agencies and Marketing detailed the facts and figures of the Knights of Columbus Insurance Program. I was a bit surprised at the 1.6% penetration of our group.

And Frederick J. Abraham, Jr., Executive Vice President Fraternal. reminded us that the chaplain and the Grand Knight should try to come to an understanding of what to expect from the Council. He noted the need for leadership in the Council, a leadership that is founded on the power to inspire and work together. The chaplain should help identify prospective Knights and help define programs to benefit the Parish and community. VP Abraham noted that the chaplain should communicate with the Grand Knight on a regular basis and attend meetings and much, much more.
