## STATE DEPUTY'S RULES FOR RETENTION/SUSPENSION BY DANIEL LECHNER, PSD, STATE RETENTION CHAIR

The following information is offered in order to clarify the State's position on suspensions, discussed at the Regional Schools of Columbianism:

From its establishment, the Mississippi Knights of Columbus has lost more members through death, withdrawals and suspensions than we presently have in total membership, a trend we cannot allow to continue. With the State Deputy's blessing, we have devised some rules that must be followed in an effort to reverse this trend.

Rule No.1 - Establish a Retention Committee to examine reasons why Knights become inactive and let their membership lapse. This committee plans programs to conserve the Council's membership and anticipate and solve problems that may cause membership suspensions. The Deputy Grand Knight should be named to the position of Retention Chair and his committee composed of the Council's Trustees. After discovering problems, the committee should work with Council officers to remedy them.

The Financial Secretary should provide the Retention Committee with a list of members in danger of being suspended. The Retention Committee contacts these members and discusses their reasons for being inactive and urges them to pay their dues and become active again. The Financial Secretary can also furnish a list of suspended members. The committee should also contact former Knights who still meet membership eligibility requirements and ask them to reioin.

Rule No. 2 - Supremes' theme this year is "You are Your Brother's Keeper." When you have a member that is up for suspension, think of him as your brother and do everything in your power to save him. Remember that someone put in a lot of effort to make him your "brother," so you owe it to him to put in as much effort to save him. Never suspend a brother Knight because he can't pay

his dues. Suspend him because he won't pay his dues.

**Rule No. 3** - When you have completed Rule 1 and Rule 2 and your "brother" cannot be saved, you must follow the proper procedure for suspension.

### **JURISDICTION PROCESS TO SUSPEND**

The following guidelines are in place to ensure the correct procedure is followed during the suspension process:

- 1) You must have a current form 365 on file at Supreme with a Retention Chairman listed.
- 2) The process to suspend must be followed as outlined in the Financial Secretary Manual dated Jan 2011, Page 4 Billing and page 53 Suspension Non-Payment.
- 3) You must have completed the semiannual audit report form 1295 or 1295-2 correctly (see page 44 Schedule C, sample 1295 on page 46 of the FS Manual).
- 4) A copy of your Council's "Outstanding Balance Report" and a copy of the "Retention Committee Report" with the 1845s must be mailed to the State Deputy and District Deputy.

Failure to follow the above procedures will null the proposed suspensions.

Note: The State Deputy has the authority to approve or disapprove suspensions.



## KC COUNCILS TEAM-UP ON WORTHY FUNDRAISER BY GREGORY KELLER, COUNCIL 15121

Lumberton Our Lady of Perpetual Help Council 7211 and Poplarville St. Joseph Council 15121 responded to the plea of the grandmother of Michael 'Buddy' Sherrill, 6, who was born with quadriplegic spasmatic cerebral palsy and fetal alcohol syndrome and underwent open heart surgery at the age of 6 months. Buddy is confined to a wheelchair but has a very upbeat attitude and an engaging personality.

His grandmother contacted the Councils and advised that a procedure called PERC or Percutaneous Muscle Lengthening would allow Buddy to be able to independently sit up by himself, stand and possibly walk with the assistance of braces and a walker.

The Councils took on the organization of fund raisers to offset the family's out-of-pocket medical expenses and accommodations while in New





Jersey, where the surgery was performed in August. They held spaghetti and meatball fund raisers in July, raising approximately \$14,0000.

The word of this fund raiser spread through the K of C family and inspired other Councils to lend a helping hand. Council 12989 of Lacombe, LA., donated funds toward the total amount raised. Grand Knight Fred Cowburn of Council 783 in Summit, NJ, was contacted and his Council assisted the family during their stay in New Jersey.
