SUPREME RECOGNIZES 37 STATE COUNCILS FOR 2012 ACHIEVEMENTS

Fourteen Councils in the Mississippi Jurisdiction achieved Star Council status in the 2011-12 Fraternal Year, four rising to Double Star Council for attaining 200 percent of their membership recruitment quota.

The Columbian Award also was bestowed on 14 Councils, with five receiving the Fr. McGivney Award and four receiving the Founder's Award.

The Star Council Award recognizes outstanding achievement in membership recruitment and retention, promotion of the fraternal insurance program and sponsorship of service-oriented activities. To earn the Star Council Award, a Council must qualify for all three other awards.

Councils conducting and reporting four major programs in each of the Service Program categories qualify for the Columbian Award. The Fr. McGivney Award is presented to Councils achieving their associate member quota; and the Founder's Award recognizes Councils achieving their insurance member quota.




tume prizes for all ages, from youth to adult, and prizes for the best pumpkins drawn with eyes closed were provided to cap a very successful and well-attended event.
