### Supreme Convention Inspires





## Track Activities as They Occur

An updated State Program Activities Report for the new year is posted to the State website so Councils can begin tracking activities as they occur rather than trying to remember at the last minute everything the Council did in the report period.

State officers added several new program suggestions for counsels including:

- Perform their own First Degree Exemplification;
- Host or perform their own Second and Third Degree Exemplifications;
- Participate in the State Second Responders Program.

There is a plan for the development of an on-line database that would make it easier for officers to keep up with activities as the year unfolds. For now, however, officers can print the report from the State website and check off activities as they occur. That should make it easier to keep tabs on activities to include in the mid-year report that is due on or before Nov. 1.

Twenty-two Councils in the state did not file the report last year. Officers are encouraged to visit the State website to review the form and plan activities for delivery in plenty of time to meet the deadline. 
