Giving Thanks



Tax Reporting Tips from the State Advocate



Brother Knights,

As State Advocate, part of my job is giving the Councils and Assemblies information about filing yearly with the IRS. Depending on whether you chose a calendar year or the Supreme year which ends 6/30 your 990 filing with the IRS is due 5/15/2013 or 11/15/2013 respectively. So your filing is already due or will be due on 11/15. Both Councils and Assemblies have to file the 990 yearly.


You will need your EIN number to file. Unless your annual income is greater than \$50,000 you can file on

line. The State website <u>www.kofc-ms.org</u> has a 25 page information sheet that Supreme sent to me. It goes into great detail about what you need and how to file. It also tells you how to get an EIN # if you do not have one. In a lot of cases the bank where you have your checking account will have the EIN in their records. Check with them if you cannot find it.

Go to the website listed above and click on "for officers". Then click on "forms, contacts and more". The third topic down is "IRS information". Click on "form 990/990EZ information". That will bring up a 25 page PDF file from the Supreme Advocate. As mentioned earlier it goes into great detail about how to file, shows examples of forms, and has frequently asked questions at the end.

Also in that same field is "IRS Exempt Organization Check". If you click on that it will take you to an IRS website to see if your Council or Assembly has filed. You will need your EIN # to use this.

You have to be registered with the IRS and Supreme to use our 401-c exemption. If



Supreme has not told the IRS that you are under their banner, the IRS will not recognize you.

If you have read the 25 page PDF file that I mentioned earlier, and you still have questions, contact me about your problem to see if we can resolve it. My email is <u>philip-jabour@bellsouth.net</u>. I am also the contact for the State Insurance program that the Councils and assemblies can participate in. But, that is a topic for another day.
