Here I am Lord

I had the pleasure of attending the official launch of the Holy Family Traveling icon at St. Therese in Jackson just before Christmas. State Chaplain Msgr Elvin Sunds was the celebrant at the preceding mass. Many of those present were KC families and were impressed with an impressive honor guard. His homily was focused on family. He was directing it to me.

Last month we talked about *indifference* and the harm it causes not just in society but even at our supper table. One of my favorite TV shows is Blue Bloods. The Reagan family gathers each Sunday after mass for lunch as a family. No plates on coffee tables or in a lap. They all sit around the family table and pray our traditional blessing. Topics usually float between honor, integrity and the sometimes heavy

burden of doing the right thing. Sometimes tempers flare and feelings get hurt, just like at home. The one constant is their love for one another. In every instance, things are resolved within sixty minutes. In real life, those hurts and resentments can for run years before they are addressed. Some continue after one of the parties dies. More often a healing begins as the result of a wedding or a funeral. The funeral is when folks reflect on their own mortality and see how insignificant that offense really was.

Pope Francis has declared this to be a Year of Mercy. How fitting that we are able to condense his powerful message in that announcement to two words: Forgiveness and Confession.

Both are good for your health.

As we begin this wonderful New Year, it's important to set goals.

Mine are simple: Welcome 225 good Catholic men into the Knights. Establish 50 Roundtables. Bring the Holy Family icon to 125 churches. Attend mass with our Mississippi Knights on Bikes at a mission church.

Dear Brother Knight,

Baby Bottle Boomerang Overview

A Culture of Life Fund Raising Program

It's really simple...it's called a Baby Bottle Boomerang because you distribute empty baby bottles to church and council members, and just like a well-tossed boomerang, they come back to you full of coins, currency and checks. And, the bottles can be used over and over again, creating an ongoing fundraising and promotional program within your church community. Try to make it an at least an annual activity and involve different church groups.

The Baby Bottle Boomerang will help your Council to:

- · Increase the numbers that hear your pro-life message.
- Elevate the awareness level of your ministry in the community.
- · Raise significant funds with relatively low up-front costs.

What is it?

The Baby Bottle Boomerang is one of the most effective fundraisers for pro-life ministries in use today. It is easy to do and it is a great way to involve all members of your council and parish.

The Baby Bottle Boomerang is simple to conduct, effective in communicating your message, and very productive in raising much-needed funds, regardless of the size of your church or council. It is an easy, convenient way to involve families and individuals in your parish. No extra meetings or time commitments are required of the participants.

How does it work?

You announce the Baby Bottle Boomerang in your church bulletin for two weeks and distribute the bottles after mass or any other function on the announced date. You ask everyone to take home a baby bottle, fill it with spare change or any size donation, and return the filled bottle after mass in a two or three weeks at the date you announce. It is best to collect the bottles on two dates because some people will forget to return them on the first collection date. Then your Council, Ladies Auxiliary or Youth Group counts the money and decides what prolife organization or crisis pregnancy center will receive your donations.

Distributing and tracking the bottles

You should write a number on the bottom of each bottle so you can track the bottles that have been returned.

It is best to have a sign-up sheet to record the bottle number with name, phone number and Email of the person who took that bottle so you can remind them to return their bottle and donations on the designated date and time.

Where to buy the bottles

You can buy them locally or purchase bottles with special prolife messages and images on them from Heritage House 76 at: <u>http://www.heritagehouse76.com/default.aspx?GroupID=201</u> or call them at 1-800-858-3040. The bottles cost about \$1.00 if you order120 of them.

Results

Since its inception in 2001, over 1,400 pro-life organizations have used the Baby Bottle Boomerang to raise over \$70,000,000. The normal return for one carton of bottles (200) the first time the program is done is approximately \$2,100 based the experience 1,400 pro-life organizations. The average amount raised from one box of 200 bottles, when used repeatedly until all bottles are depleted, is generally about \$5,100.

State Mid-Year Leadership Meeting Held in Jackson

Mississippi was honored to have Vice President of Training and Ceremonials, Gary Nolan, and our Membership and Program Consultant, Joe Ramirez attend this meeting. Much of our focus was on training, Building the Domestic Church: Strengthening the Parish and the Holy Family icon and inviting good Catholic men to become members of the Knights of Columbus. Bishop Joseph Kopacz addressed the attendees at lunch, praising the KCs for their many good works and stressed the importance of being even more involved within the parish.

Brother Nolan played a major role in producing the latest Success Planner which all agreed is very useful. When asked how many DDs brought their planner... the response was outstanding. A special photo was taken with Gary demonstrating the commitment of Mississippi's district deputies.

At the conclusion on Sunday, the District Deputies gave updates on their districts and talked about how we will grow the state through increased first degrees, more opportunities for members to advance through the Second and Third degrees within the first year of membership. All agreed it is important for each council to establish and rely on an effective retention committee.











Volunteer Reception Center Called Into Action

Wednesday, December 23, 2015 a strong line of storms raced across several states leaving a path of destruction that resulted in several deaths as well as a wide track of homes damaged, some even completely destroyed. One of the areas that received a great deal of damage is Holly Springs, MS. A reported EF-4 tornado with multiple vortices swept through the area in the late afternoon devastating multiple areas of Holly Springs and surrounding Marshall County.

After the storm passed and dawn broke families, first responders, and other law enforcement agencies began to understand the enormity of the situation at hand. The local Emergency Management Agency (EMA) was quick to respond by signaling for help for the Mississippi Emergency Management Agency (MEMA) as well as other state-wide agencies.

On Christmas Day, realizing the need for manpower, Kathryn Replogle, Disaster Services Coordinator with Mississippi Commission for Volunteer Service/ Volunteer Mississippi contacted Knights of Columbus Past State Deputy Jerry Schmuck, who is also the K of C State Disaster Response Director, and asked if the Knights would be able to establish a Volunteer Reception Center (VRC) in Holly Springs to support the relief effort.

The purpose of the VRC is to document unaffiliated volunteers who want t0 lend their time and skills to disaster relief needs but are not a member of any specific group. MCVS and other state and federal agencies require that the unaffiliated volunteers be registered to track man hours worked, where volunteers are working, what type of work they are doing, what type of equipment is being used, etc. It also mandates that

the volunteers go through safety training to help prevent injury in the field. Once properly registered, the VRC deploys the volunteers to different areas of need based on their skill sets. The VRC tracks the progress of all ongoing work that it has set in motion. The VRC also will provide daily

statistics to government agencies for their tracking purposes. PSD Schmuck set the ball in motion and on Saturday, December 26 the VRC was up and running. Knights from several districts and many more councils have stepped up to staff the VRC as well as volunteer in the

field helping residents remove debris, place tarps on roofs, and more.

The VRC is expected to operate for 1-2 weeks and more volunteers are needed daily to help staff the VRC located at the First Baptist Church Activity Center at 190 E. College Ave. located 2 blocks east of the square in Holly Springs. No particular skills or tools are needed for the office work and training will be done as needed and the volunteers matched to duties they are able to perform. Work crews will also be dispatched as additional homes are assessed and identified along the path of the tornado damage on the south and east sides of Holly Springs.
