Remember even if a Council reaches its membership and insurance goals, Star Council will be denied without the training. GET'ER DONE.

WASHINGTON – In the wake of a disaster, Americans have always come together with compassion and courage to ask how they can help survivors. For Hurricane Maria, there are three ways that the public can leverage the expertise and experience of non-profit, faith- and community-based organizations and private sector partners to most effectively and efficiently help provide support for survivors in Puerto Rico and the U.S. Virgin Islands, and ensure that an individual contribution – whether financial donation or personal volunteerism – is carried out responsibly.

The fastest way to help - cash is best

The most effective means to support recovery of communities affected by Hurricane Maria is to donate money to trusted voluntary-, faith- and community-based charitable organizations. This gives these organizations the ability to purchase what survivors need right now. In addition, when these organizations purchase goods or services locally, they pump money back into the local and regional economy, helping businesses recover faster.

The National Voluntary Organizations Active in Disaster (NVOAD) list trusted organizations receiving donations, many of which are already coordinating relief and response efforts in the Caribbean. To make a cash donation directly to the Commonwealth of Puerto Rico, visit www.unitedforpuertorico.com. You may also make financial donations to a National VOAD member organization to help voluntary or charitable organizations continue to provide services to Hurricane Maria survivors.

Donating Goods

It is important to remember unsolicited donated goods (e.g., clothing, miscellaneous household items, and mixed or perishable foodstuffs) require voluntary agencies to redirect valuable resources away from providing services to sort, package, transport, warehouse, and distribute items that may not meet the needs of disaster survivors.

To responsibly donate goods, the NVOAD website has information on non-profit organizations accepting or registering individual and corporate in-kind donations here.

Volunteering

Anyone seeking an opportunity to get involved in response and recovery operations underway is encouraged to volunteer with local and nationally known organizations. A list of volunteer websites is available at www.nvoad.org.

Puerto Rico and the U.S. Virgin Islands ask that volunteers not self-deploy, as unexpected arrival in affected communities creates an additional burden for first responders. Volunteer registration for Hurricane Maria can be conducted here for Puerto Rico and here for the U.S. Virgin Islands.

To register as an affiliated volunteer with a voluntary or charitable organization, visit the National VOAD for a list of partners active in disaster. Alternatively, you may register to volunteer here for partner organizations to reach out to you.

Patience is paramount, and the need for volunteers endures. Recovery activities associated with Hurricane Maria will require volunteer engagement for many months and years to come, and the help of many will be required.

FEMA's mission is to support our citizens and first responders to ensure that as a nation we work together to build, sustain and improve our capability to prepare for, protect against, respond to, recover from and mitigate all hazards.

FAMILIES UNITED IN CHARITY 8/1/2016

AS DOMESTIC CHURCHES, OUR FAMILIES ARE CALLED TO REACH OUT BEYOND THEMSELVES IN LOVING SERVICE

NOT LONG AGO, I had the joy and honor of ordaining a priest who comes from a large and wonderful Catholic family. The night before his ordination, I hosted a Holy Hour and dinner at my residence in Baltimore. I sat next to the ordinand's father, and as we talked, two qualities of his character stood out: his love for his family and his love of the Lord. The young man's mother likewise showed a deep love for the Lord and her family, and it was clear she is also a very organized and disciplined person. I got the impression she could run a Fortune 500 company!

As the evening progressed, I became more and more impressed with this family. Some of the older siblings had just returned from a weeklong walking pilgrimage from Annapolis to Ocean City, Md. They had joined with other young people in bearing witness for religious freedom. And as busy as this family is, they find the time to readily reach out to others in need. They are involved in all sorts of service projects, making their home a place of hospitality and a bustling domestic church.

All this was summed up when one of the young man's sisters stood and made a toast. Her words were filled with

joy at the very thought of her brother's ordination, but they also contained a challenge: to be a priest who serves others in a spirit of open-hearted love. In this way, she radiated the beauty of a family that embodies the spirit of charity that should animate the whole Church. In the words of Jesus, "The greatest among you must be your servant" (Mt 23:11).

LOOKING OUTWARD

Over nearly 40 years of priestly ministry, I've been privileged to know many families that reach out in loving service in their local parish and to the wider community. Like all families, they have their ups and downs, their triumphs and tragedies. Parents have their share of disagreements and financial worries, and their children experience the joys and the challenges of growing up in today's culture. Yet for all their trials, such families never turn in on themselves. They live simply and often deny themselves luxuries that other families consider to be necessities. They don't split apart, each member of the family withdrawing to his or her digital corner. Instead, they stay together and maintain strong family ties, and their love spills over, far beyond their home. Their lives are marked by a spirit of service that looks outward. Strangely enough, by looking outward to the needs of others, they maintain the inner unity of hearth and home. To echo St. Francis of Assisi, it is in giving that they receive.

Families are united in service in many ways. Many participate in Knights of Columbus activities or parish outreach efforts, such as food pantries. Sometimes I see families volunteering in larger initiatives run by Catholic Charities or in other activities, such as rehabbing homes or helping veterans.

In addition, these families often unite in love by welcoming to their homes those who might need a bit of encouragement or companionship. Many years ago, when my own family was in the process of moving, my father had to remain behind at our previous home for a few weeks. During that period, he often received invitations to dinner from families in the parish, because they knew he was separated from his own loved ones. How many people in their advancing years, perhaps widows or widowers, would like to spend an evening with a welcoming family?

'UNITED IN SERVICE'

As we know, a parish is called to be a community of faith, worship and service. Pope Francis goes a step further and challenges parishes not to become "a useless structure out of touch with people or a self-absorbed group made up of a chosen few." Instead, the parish is to be known as "an environment for hearing God's word, for growth in the Christian life, for dialogue, for proclamation, charitable outreach, and celebration" (Evangelii Gaudium, 28).

If the family is a domestic church, that is to say, "the Church in miniature," then it must avoid the same pitfalls and exhibit the same virtues. Family members cannot allow themselves to withdraw from one another, from their extended families, or from the parish and the wider community. Pope Francis warns that "some Christian families, whether because of the language they use, the way they act or treat others, or their constant harping on the same two or three issues, end up being seen as remote and not really a part of the community" (Amoris Laetitia, 182). The family must create a loving environment where both parents and children hear God's word, share it, talk about their joys and sorrows in light of it, and proclaim it by their lives of love and service to others.

A family that reaches out in love to others will have no trouble in seeing Sunday Eucharist as the culmination of their week and as the place where they are renewed for further love and service. This is a special challenge for Knights of Columbus families. Charity is our first principle, and we proclaim ourselves "united in service." May our families also be united in service to One, in service to all.

ANSWERS TO FREQUENTLY ASKED QUESTIONS ABOUT THE NEW FOURTH DEGREE UNIFORM

Earlier this month, the Knights of Columbus board of directors unanimously voted to adopt a new uniform for the Fourth Degree. The decision was made with the good of the entire Order in mind. While we understand that some members may prefer the old regalia, the supreme master and vice supreme masters urge all Fourth Degree members to put the good of the Order before any personal preference.

The board decided to make this move based on the following factors:

- the aging of our Fourth Degree membership
- the slow growth of the Fourth Degree (fewer than 20 percent of Knights are Fourth Degree members, and only a fraction of that number even serve as honor guards)
- consistent reports that the old regalia presented a barrier to Fourth Degree membership, especially among younger men

The following FAQ should answer many of the questions that have arisen concerning this change.

Q: Will the new uniform allow the use of ceremonial swords?

A: Yes. Ceremonial swords will continue to be part of the Fourth Degree. When swords are used, gloves should also be used. (see picture above).

Q: How will rank be distinguished?

A: Colored patches will be worn on the beret behind the Fourth Degree emblem as follows:

- Dark Blue Supreme Master
- Light Blue Vice Supreme Masters
- Gold District Masters
- White Faithful Navigators
- Green District Marshals
- Purple Color Corp Commanders

Those not holding office (who formerly wore red capes) will wear berets with no patch.

Q: Where can I buy the new unifom?

A: www.knightsgear.com

Q: Will there be discounts offered on the new uniform?

A: Yes. The Order will subsidize the new uniform with a 25 percent discount offered to all members who order the new uniform prior to Sept. 30, 2017.

Q: What if a member just purchased the old regalia?

A: Any member who purchased the old regalia after May 1, 2017, can submit their receipt along with their member number to regaliacredit@kofc.org. Information will then be sent to that member on how to receive a \$200 credit toward the new uniform.

Q: Is the Order making money on the new uniform?

A: No, the uniform is being sold at (or sometimes below) our cost.

Q: Was the new uniform field tested prior to its release?

A: Yes. The new uniform was field tested by Fourth Degree members attending the Warriors to Lourdes pilgrimage.

Q: Can the old regalia still be worn?

A: Yes, for a time. While the preference is for the new uniform wherever possible, the old regalia can still be worn until the end of the current fraternal year (June 30, 2018). After that date, only the new uniform should be worn.

Q: Who made this decision?

A: The board of directors made this decision earlier this year after a three year period of testing and discussion. In addition, changing the uniform/regalia was previously discussed with the vice supreme masters at the Supreme Assembly.

Q: Did members have input on this?

A: For years, supreme officers and directors have received comments from members and prospective members that the old regalia was a barrier to membership overall, or to membership in the Fourth Degree.

Q: In what context should this change best be understood?

A: During the convention, the Good of the Order Committee stated: "We commend all of the faithful Sir Knights who have proudly worn the Fourth Degree regalia, bringing much respect to the Order. With the new Fourth Degree uniform, recently approved by the Board of Directors, this honor and respect associated with Sir Knights will remain, and it will open the door more widely for a new generation to join their ranks. In a spirit of unity, let us assist with a smooth transition to this new uniform and encourage it to be worn with great dignity and pride."

It is that time of the year again to begin thinking about the annual Knights of Columbus Citizenship Essay Contest. The rules for the contest are below:

Theme and Topic

The theme of the Knights of Columbus Essay Contest is: "Going to the Peripheries."

Guidelines

- Essays must reflect the assigned theme and topic, and be submitted by the published deadline.
- Essays must be the student's original work.
- Essays must be typed on 8 1/2" X 11" paper, one sided, double spaced, with one-inch margins.
- Essays must be between 500 and 750 words long.
- The student's name should appear only on the official Knights of Columbus Essay Contest entry form which should be stapled to the essay.
- All entries become the property of the Knights of Columbus and will not be returned.

Judging

Judges will be selected by the sponsoring Knights of Columbus council, assembly or circle. Council, assembly members, clergy, civic officials and/or members of the community may serve as judges.

Essays will be judged on a 100-point scoring system: 35 points: Content — How clearly is the theme presented?

30 points: Grammar — How well is the essay written with respect to sentence structure, paragraph construction and spelling?

35 points: Style — Does the essay show creativity, imagination and development of the topic in a compelling style?

The Essay Contest council participation form (#4216) for the council level should be filled out and sent to the Supreme Council Department of Fraternal Mission by January 30.

I must have all Essays from the local and regional contests by March 15 so that I can get them judged and sent to Supreme by April 15. Winners will be announced at the 2018 State Convention. Keep Christ in Christmas Poster Contest

It is time to begin thinking about conducting the Annual Keep Christ in Christmas Poster Contest. The rules for the KCIC Poster Contest are as follows:

Topics/Categories: Each poster must reflect the Keep Christ in Christmas theme with a visual image. There is no limit to the number of posters each contestant may submit.

Age Groups: Contest entrants compete in one of three age groups — ages 5 through 7, ages 8 through 10 and 11 through 14. Sponsoring councils should use their own judgment in deciding how to group participants. Each local, district, regional or state competition may have up to 6 winning entries — a first and second place winner in each age group

Rules: • Poster must reflect the theme of Keep Christ in Christmas. • Each poster should be the original work (including concept, layout, slogan and any visual images) of a single person. • Poster must be approximately 11X17 inches. If pastels, chalk or charcoal are used the poster must be laminated or covered with clear plastic. • Each poster must be submitted with a Knights of Columbus "Keep Christ in Christmas" Poster Contest entry form (#5025) — make sure your council number is included. The name and age of the entrant should be printed on the reverse side of the poster in case the poster and entry form get separated. • All entries become property of the Knights of Columbus Supreme Council office. Posters will not be returned.

Judging: Judging teams should be composed of students, Knights, teachers, administrators, council Chaplain, pastor, etc. A 100-point scoring system will be used to determine the winners. Slogan — 30 Points: How clearly is the theme presented? Visuals — 30 Points: How well do the visuals convey the message? Overall Impact — 40 points: How effective was the poster in capturing your attention and causing you to reflect on the topic at hand?

I need all submissions for your local and regional contests by January 31 so that the 1st place poster for each age group can be submitted to the Supreme Council by February 28. The State winners for each age group will be announced at the State Convention. Please send all posters to my home address at **668 Orchard Dr. D'Iberville**, **Ms. 39540** or they can be submitted at the Mid-Winter Meetings held in early January. Silver Rose Devotional







Council 10901 St. John the Evangelist

Our Lady of Guadalupe, the Patroness of North America, on September 7th at the Knights of Columbus St. John the Evangelist Knights of Columbus Council 10901 participated in the international devotional to meeting Room at St. John.

At the conclusion of the Devotional, the Silver Rose was carefully packed in its travel box for it's journey to the next Knights jurisdiction. This year, the Silver Rose was received from the Batesville Council and was carried to the Meridian Council by James Reid, the Coordinator for this year's Devotional.

Our Lady of Guadalupe Silver Rose Pilgrimage has been a tradition for 57 years and was started by a youth group associated with the Knights called the Columbian Squires in 1960. The devotional to Our Lady of Guadalupe was officially adopted by the Knights in 2001. Since then every North American Knights of Columbus jurisdiction, including those in Canada and Mexico, participate in this devotional.

One of 6 Silver Roses is carried across 6 different corridors in the Western, Central and Eastern portions of North America, with Knights hand-carrying a Silver Rose, in specially constructed boxes, from one Knights of Columbus Council location to the next. Each Rose does not stay at any Council for more than 24 hours. East destination is an occasion for prayer and spiritual renewal centered on the rosary, prayers and scripture readings.

Two of the six roses will end their journey at the Shrine of Our Lady of Guadalupe in Monterrey, Mexico, on December 12th, and become an integral part of the celebration of the Feast Day of Our Lady of Guadalupe on that day.

In all, the six Silver Roses will have passed through many cities and towns, traveling thousands of miles and being handled by as many hands. Likewise thousands of prayers and rosaries will have been recited as a part of this international Devotional.

The 6 silver roses will resume their pilgrimage in 2018, following different routes and visiting as many Knights of Columbus jurisdictions as possible.






