He is responsible for a record of the convention proceedings and collecting the various reports so the he may organize them in the Convention Minute Book. His most solemn responsibility is to read the necrology at the annual Memorial Mass held on Saturday morning of Convention weekend. The one unwritten duty of the State Secretary is make arrangements for the Wednesday night Delegates' Dinner at the Supreme Convention. It is his job to pick the restaurant and make the reservation for the Mississippi Delegation.

July Membership Report

First congratulations to Larry Moeller and Eugene Valentine of Council 10216, John Piazza and John Moore of Council 898, Corwyn Peterson and Henry Knue of Council 9673, Christopher Trapani of Council 1522, and David Fisher, Louis Clifford, and Gregory Hampton of Council 15131. Each of these brother Knights earned a Mississippi Fast Start Recruiter Mug for recruiting at least one new member in July. The top recruiter for July was Louis Clifford (Council 15131). In July, the state only recruited 17 new members so we did not award the \$100 recruiting incentives. These were rolled forward to August. As of August 12th, the state had brought in 12 new members for August. Keep up the good work!



District Deputies, keep looking at your monthly goals. Remember your goal plus one puts the state back into the Circle of Honor next year at the Supreme Convention. Council leaders, encourage your members to look at the men standing next to them at Mass and ask if they are a member of the Knights. We only had four Star councils last year and we should have had many more. Remember, if your council earns the Star Council award this year, Supreme will give your council a half year credit on your per capita in the 2020-2021 fraternal year and if your council earns it by January 15, 2020, the state will also give a half year credit next year as well. That is a credit of over seven dollars for each dues paying member in your council. Imagine the increase in charitable works

Note to the financial secretaries, when you submit a form 100 to Supreme with a new member, I do not get a copy from Supreme. The only way I can track proposers for the year and present these incentive awards is when you send a copy of the form 100 to me (membership@kofc-ms.org). A quick time saver is to set up a "Form100" email group with the following five e-mail addresses:

membership@kofc.org Supreme Membership Records membership@kofc-ms.org State Membership Director dd##@kofc-ms.org Your district deputy your.field.agent@kofc.org So he will get a heads up Charlie.Groves@kofc.org The Stice Agency

Then, when you have a first degree, scan in the form100 and e-mail it to your "Form100" group and all of us will get a copy. While Supreme will send the Stice agency the new member's information, sending a copy to the field agent and the agency directly gives them a head start on talking to the new member about the benefits he is eligible for.

And now for the least popular topic of the month – Retention. I know that councils want to shed those members who aren't paying their dues, but do you drop a man who is 68 with 44 years of service? How long has that member gone without paying their dues? If it is only a couple of years, then perhaps the council could waive his dues until his 70th birthday or find someone who can pay his dues? Has anyone reached out to contact the member to see how he is doing? It would be sad to suspend an elderly member who the council later found out passed away in another town. That said, I urge councils to use the retention procedure and form that was rolled out last year:

This form outlines the proper procedure to drop an individual from the council rolls. It is important to make a good faith effort to try to contact the member to see why he is behind on his dues or if he is still interested in being a part of the Knights of Columbus. If a council has lost contact with a member, the state has subscribed to a locator service that can be used to find update contact information – contact myself or the state secretary for a report. I recently reviewed a conservation report. When I contacted one the members on that report, he was unaware that he was behind on his dues and he promised to pay not only his dues, but his son's dues which were delinquent too. That is unacceptable. That tells me that that council did not make a good faith effort to contact the members before initiating the suspension process. I urge councils to follow the proper procedure and do what they can to avoid suspending a member unnecessarily. And remember – the time to start working on member retention is when you talk to the prospective member about joining. Get him involved early on and make him feel that his efforts are appreciated. Then he won't become one of those members who has to be suspended.

Degree Knight. The Brother Knights of Natchez are looking forward to having both of these fine young men as part of their Council and Assembly.


